I. STEWART ANNEX. Effective 1 August 1972, that portion of the former Stewart Air Force Base, NY which has been officially transferred to the Department of the Army is designated Stewart Annex, a subinstallation of the West Point Military Reservation.

II. US ARMY FINANCE SUPPORT AGENCY (USAFSA). Effective 1 July 1972, the Finance Center, US Army, established at Fort Benjamin Harrison, Ind., and designated by DA General Order 22, 4 May 1967, as a class II activity of the Comptroller of the Army, is redesignated the US Army Finance Support Agency, as a class II activity under the jurisdiction of the Comptroller of the Army.

III. JUNIOR ROTC UNITS. 1. Effective 1 June 1972, a class HS JUNIOR ROTC unit will be established in the North East Independent School District, San Antonio, Texas under the provisions of AR 145-2 with training to commence August 1974.

2. Effective 1 June 1972, a class HS JUNIOR ROTC unit will be established at Newport High School, Newport, Arkansas with training to commence school year 1972-1973.

3. Effective 1 July 1972, class HS JUNIOR ROTC units are established at the following institutions under the provisions of AR 145-2 with training to commence with school year 1972-1973:

Graceville High School, Graceville, Florida
D. H. Conley High School, Greenville, North Carolina
Lumberton Senior High School, Lumberton, North Carolina
J. F. Webb High School, Oxford, North Carolina
Campbell High School, Smyrna, Georgia
Cedar Shoals High School, Athens, Georgia
Elizabethton High School, Elizabethton, Tennessee

4. Effective 1 August 1972, a class MI JUNIOR ROTC unit will be established at Linsly Military Institute, Wheeling, West Virginia under the provisions of AR 145-2 with training to commence 1 September 1972.

5. Effective 28 May 1972, the class MI JUNIOR ROTC unit at Carolina Military Academy, Maxton, North Carolina was disestablished.

6. Effective 1 July 1972, HS Junior ROTC units were established at the following institutions under the provisions of AR 145-2 with training to commence with school year 1972-1974:

North Brunswick High School, Leland, North Carolina
South Brunswick High School, Southport, North Carolina
West Brunswick High School, Shallotte, North Carolina
