**I. GENERAL COURTS-MARTIAL.** Confirming verbal orders of the Secretary of the Army of 12 June 1973, the Commanding Officer, United States Army Training Center and Fort Dix, Fort Dix, New Jersey 08640, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial *effective 15 June 1973*.

**II. GENERAL COURTS-MARTIAL.** Confirming verbal orders of the Secretary of the Army of 22 June 1973, the Commanding Officer, United States Army Combined Arms Center and Fort Leavenworth, Fort Leavenworth, Kansas 66027, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial *effective 1 July 1973*.

**III. FORT HOLABIRD, MARYLAND.** *Effective 30 June 1973*, Fort Holabird, Maryland, an active installation under the command jurisdiction of the Commander, U.S. Continental Army Command, is placed in an inactive status and concurrently designated as a subinstallation of Fort George G. Meade, Maryland.

**IV. HUNTER ARMY AIRFIELD, GEORGIA.** *Effective 30 June 1973*, Hunter Army Airfield, Georgia, an active subinstallation of Fort Stewart, Georgia, under the command jurisdiction of the Commander, U.S. Continental Army Command, is placed in an inactive status.
