I..POSITION OF THE DIRECTOR OF THE ARMY STAFF, OFFICE OF THE CHIEF OF STAFF, ARMY. Effective 20 May 1974, the position of the Director of the Army Staff will be established, combining the functions of the Assistant Vice Chief of Staff and the Secretary of the General Staff. The position of the Secretary of the General Staff will be discontinued on 20 May 1974. The position of the Assistant Vice Chief of Staff will be retained until 1 July 1974 at which time it will be discontinued.

II..OFFICE OF THE PROVOST MARSHAL GENERAL (CSWOODAA). Effective 20 May 1974, the Office of The Provost Marshal General, a Special Staff agency of the Headquarters, Department of the Army, under the general staff supervision of the Deputy Chief of Staff for Personnel, is discontinued. Concurrently, functions, personnel, and equipment will be distributed in accordance with existing requirements and regulations. The Provost Marshal General will be retained until approval of the Reorganization Order by the Congress.

III..OFFICE OF RESERVE COMPONENTS (CSWOZYAA). Effective 20 May 1974, the functions, personnel, and equipment of the Office of Reserve Components, a General Staff agency of the Headquarters, Department of the Army, will be distributed in accordance with existing requirements and regulations. The morning report and the position of Chief, Office of Reserve Components, will be retained until 1 July 1974 at which time the Office of Reserve Components will be discontinued.

IV..OFFICE OF THE ASSISTANT CHIEF OF STAFF FOR FORCE DEVELOPMENT, US ARMY (CSWOZ9AA). Effective 20 May 1974, the functions, personnel, and equipment of the Office of the Assistant Chief of Staff for Force Development, a General Staff agency of the Headquarters, Department of the Army, will be distributed in accordance with existing requirements and regulations. The morning report and the position of Assistant Chief of Staff for Force Development will be retained until 1 August 1974 at which time the Office of the Assistant Chief of Staff for Force Development will be discontinued.

V..OFFICE OF THE ASSISTANT CHIEF OF STAFF FOR COMMUNICATIONS-ELECTRONICS (CSWOONAA). Effective 20 May 1974, the Office of the Assistant Chief of Staff for Communications-Electronics, a General Staff agency of the Headquarters, Department of the Army, is discontinued. Concurrently, functions, personnel, and equipment will be distributed in accordance with existing requirements and regulations.

VI..OFFICE OF THE CHIEF OF RESEARCH AND DEVELOPMENT (CSWIBXAA). Effective 20 May 1974, the Office of the Chief of Research and Development, a General Staff agency of the Headquarters, Department of the Army, is redesignated as the Office of the Chief of Research, Development, and Acquisition.

VII. OFFICE OF THE DEPUTY CHIEF OF STAFF FOR MILITARY OPERATIONS, US ARMY (CSWOZ2AA). Effective 20 May 1974, the Office of the Deputy Chief of Staff for Military Operations is redesignated as the Office of the Deputy Chief of Staff for Operations and Plans.

VIII. DCSLOG DATA PROCESSING CENTER (SFWOLAAA). Effective 20 May 1974, the DCSLOG Data Processing Center (DDPC), a staff support agency under the jurisdiction of the Deputy Chief of Staff for Logistics, is transferred and redesignated as the United States Army Research, Development, and Acquisition Information Systems Agency, a staff support agency under the jurisdiction of the Chief of Research, Development, and Acquisition.

IX. DIRECTORATE OF COMMAND AND CONTROL AND MILITARY SUPPORT (SFW302AA). Effective 20 May 1974, the Directorate of Command and Control and Military Support (DCCMS), a staff support agency of the Deputy Chief of Staff for Military Operations, is discontinued. Concurrently, functions, personnel, and equipment will be distributed in accordance with existing requirements and regulations.

X. UNITED STATES ARMY MILITARY SUPPORT AGENCY (SFW302AA). Effective 20 May 1974, the United States Army Military Support Agency is established as a staff support agency under the jurisdiction of the Director of Military Support (DOMS), Office of the Deputy Chief of Staff for Operations and Plans.

XI. UNITED STATES ARMY COMMAND AND CONTROL SUPPORT AGENCY (SFW241AA). Effective 20 May 1974, the United States Army Command and Control Support Agency is established as a staff support agency under the general staff supervision of the Deputy Chief of Staff for Operations and Plans.

XII. TRANSFER OF FIELD OPERATING AGENCIES—CRD. Effective 20 May 1974, the following field operating agencies under the jurisdiction of the Chief of Research and Development are transferred as field operating agencies of the Chief of Research, Development, and Acquisition:

- a. United States Army Advanced Ballistic Missile Defense Agency—Arlington (SFW2ZXAA).
- b. United States Army Advanced Ballistic Missile Defense Agency—Huntsville (SFW2Z4AA).
- c. United States Army Standardization Group—Australia (SFW05FAA).
- d. United States Army Standardization Group—Canada (SFW055AA).
- e. United States Army Standardization Group—United Kingdom (SFW056AA).

XIII. TRANSFER OF FIELD OPERATING AGENCIES—AMC. Effective 20 May 1974, the following field operating agencies under the jurisdiction of the Chief of Research and Development are transferred and designated field operating activities under the jurisdiction of the Commanding General, United States Army Materiel Command:

- a. United States Army Research Office (SFW05BAA).
- b. United States Army Research and Development Group—Europe (SFW05CAA).
- c. United States Army Research and Development Group—Far East (SFW05DAA).

XIV--UNITED STATES ARMY RESEARCH INSTITUTE FOR THE BEHAVIORAL AND SOCIAL SCIENCES (SFW049AA). Effective 20 May 1974, the United States Army Research Institute for the Behavioral and Social Sciences, a field operating agency under the jurisdiction of the Chief of Research and Development, is transferred and designated a field operating agency under the jurisdiction of the Deputy Chief of Staff for Personnel.

XV--UNITED STATES ARMY OPERATIONAL TEST AND EVALUATION AGENCY (SFW3Q2AA). Effective 20 May 1974, the United States Army Operational Test and Evaluation Agency, a field operating agency under the jurisdiction of the Assistant Chief of Staff for Force Development, is transferred and designated a field operating agency under the jurisdiction of the Chief of Staff, US Army.

XVI--UNITED STATES ARMY NUCLEAR AND CHEMICAL SURETY GROUP (SFW0J5AA). Effective 20 May 1974, the United States Army Nuclear and Chemical Surety Group, a field operating agency under the jurisdiction of the Assistant Chief of Staff for Force Development, is transferred and designated a field operating agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans.

XVII--UNITED STATES ARMY AGENCY FOR AVIATION SAFETY (SFW0J7AA). Effective 20 May 1974, the United States Army Agency for Aviation Safety, a field operating agency under the jurisdiction of the Assistant Chief of Staff for Force Development, is transferred and designated a field operating agency under the jurisdiction of The Inspector General.

XVIII--UNITED STATES ARMY CONCEPTS ANALYSIS AGENCY (SFW3WCAA). Effective 20 May 1974, the United States Army Concepts Analysis Agency, a staff support agency under the jurisdiction of the Assistant Chief of Staff for Force Development, is transferred and designated a staff support agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans.

XIX--UNITED STATES ARMY RETRAINING BRIGADE (SFW2ZV AA). Effective 20 May 1974, the United States Army Retraining Brigade, a field operating agency under the jurisdiction of The Provost Marshal General, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Training and Doctrine Command.

XX--UNITED STATES DISCIPLINARY BARRACKS (SFW21BAA). Effective 20 May 1974, the United States Disciplinary Barracks, a field operating agency under the jurisdiction of The Provost Marshal General, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Training and Doctrine Command.

XXI--UNITED STATES ARMY SPECIAL PHOTOGRAPHIC DETACHMENT-CONUS. Effective 20 May 1974, the United States Army Special Photographic Detachment, an element under the jurisdiction of the United States Army Audio-Visual Agency, is transferred and redesignated a field operating activity under the jurisdiction of the Commanding General, United States Army Forces Command.

XXII--UNITED STATES ARMY AUDIO-VISUAL AGENCY, PENTAGON. Effective 20 May 1974, the United States Army Audio-Visual Agency, a field operating agency under the jurisdiction of the Office of the Assistant Chief of Staff for Communications-Electronics, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Military District of Washington.

XXIII--UNITED STATES ARMY SPECIAL PHOTOGRAPHIC DETACHMENT, PANAMA (SFWOQDAA). Effective 20 May 1974, the United States Army Special Photographic Detachment, Panama, under the jurisdiction of the United States Army Audio-Visual Agency, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Forces Command.

XXIV--UNITED STATES ARMY SPECIAL PHOTOGRAPHIC DETACHMENT, PACIFIC, FORT SHAFTER (SFWOQBAA). Effective 20 May 1974, the United States Army Special Photographic Detachment, Pacific, Fort Shafter, under the jurisdiction of the United States Army Audio-Visual Agency, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Forces Command.

XXV--THE MOTION PICTURE DISTRIBUTION AND DEPOSITORY DIVISION, TOBYHANNA. Effective 20 May 1974, the Motion Picture Distribution and Depository Division, Tobyhanna, under the jurisdiction of the United States Army Audio-Visual Agency, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, United States Army Training and Doctrine Command.

XXVI--UNITED STATES ARMY MEMORIAL AFFAIRS AGENCY (SFW3P9AA). Effective 20 May 1974, the United States Army Memorial Affairs Agency, a field operating agency under the jurisdiction of the Deputy Chief of Staff for Logistics, is transferred and designated a field operating activity under the jurisdiction of the Commanding General, The Adjutant General Center.

XXVII--UNITED STATES ARMY ENGINEER STRATEGIC STUDIES GROUP (CEW2U8AA). Effective 20 May 1974, the United States Army Engineer Strategic Studies Group, a staff support agency under the jurisdiction of the Chief of Engineers, is redesignated the United States Army Engineer Studies Group, a staff support agency under the jurisdiction of the Chief of Engineers.

XXVIII--UNITED STATES ARMY MANAGEMENT SYSTEMS SUPPORT AGENCY (SFWISEAA). Effective 20 May 1974, the United States Army Management Systems Support Agency, a staff support agency under the jurisdiction of the Assistant Vice Chief of Staff, Army, is transferred and designated a staff support agency under the jurisdiction of the Director, Management Information Systems, OCSA.

XXIX--UNITED STATES ARMY COMPUTER SYSTEMS SUPPORT AND EVALUATION COMMAND (SFW2Y2AA). Effective 20 May 1974, the United States Army Computer Systems Support and Evaluation Command, a staff support agency under the jurisdiction of the Assistant Vice Chief of Staff, Army is redesignated the United States Army Computer Systems Support and Evaluation Agency and is transferred, as a staff support agency under the jurisdiction of the Director, Management Information Systems, OCSA.

XXX--UNITED STATES ARMY COMPUTER SYSTEMS COMMAND (SFW248AA). Effective 20 May 1974, the United States Army Computer Systems Command, a field operating agency under the jurisdiction of the Assistant Vice Chief of Staff, Army, is transferred as a field operating agency under the jurisdiction of the Director, Management Information Systems, OCSA.
