I\_THE PRESIDENTIAL UNIT CITATION (ARMY). Award of the Presidential Unit Citation (Army) by the President of the United States of America to the following units of the Armed Forces of the United States is confirmed in accordance with paragraph 194, AR 672-5-1. The text of the citation, signed by President Richard Nixon on 15 May 1974, reads as follows:

By virtue of the authority vested in me as President of the United States and as Commander in Chief of the Armed Forces of the United States, I have today awarded

The 229th Assault Helicopter Battalion distinguished itself by extraordinary heroism in action against hostile forces during the period 5 April 1972 through 7 July 1972 while serving in support of the Government of Vietnam defenders of the provincial capital of An Loc, Binh Long Province during the North Vietnamese Army "NGUYEN HUE" Offensive. Through their courage, determination, and ingenuity the troopers of the 229th Assault Helicopter Battalion and assigned and attached units, overcame the difficulties engendered by the introduction of new weaponry by the enemy and the most intensive volume of anti-aircraft artillery fire yet experienced, while supporting

and sustaining the beleaguered defenders against the enemy onslaught. The successful defeat of the enemy by the forces of the Government of Vietnam would have been vastly more prolonged and costly were it not for the invaluable support rendered by the 229th Assault Helicopter Battalion. The outstanding devotion to duty, perseverance, and extraordinary heroism of the members of the 229th Assault Helicopter Battalion and its assigned and attached units under the most hazardous conditions are in keeping with the finest traditions of the United States Army and reflect great credit upon themselves, the Army, and the United States of America.
