**I. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Warrant Officer *George W. Grega*, , United States Army, for action on 2 November 1969. This award is authorized under the provisions of paragraph 11c, AR 672-5-1.

**II. DISTINGUISH FLYING CROSS.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, the Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to:

Specialist Five *Edward B. Trealer*, , United States Army, for action on 11 March 1971. This award is authorized under the provisions of paragraph 11c, AR 672-5-1.

Captain *James A. Youndt*, , Infantry, United States Army, for action on 7 January 1968. This award is authorized under the provisions of paragraph 11c, AR 672-5-1.

**III. SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Staff Sergeant *Donald W. Boren*, , United States Army, for heroism on 11 May 1973.

Specialist Four *Tommie L. Knight*, , United States Army, for heroism on 11 March 1973.

Private Second Class *Ernest V. Pacleb*, , United States Army, for heroism on 28 October 1973.

Private Second Class *Eric G. Pinkerton*, , United States Army, for heroism on 28 October 1973.

This award supersedes the Army Commendation Medal awarded by The Commander, United States Army Combat Developments Experimentation Command, Fort Ord, California 93941, under the provisions of paragraph 7a, AR 672-5-1, to Private Pinkerton for heroic actions on 28 October 1973.

Specialist Five *Tom Smith*, , United States Army, for heroism on 10 October 1973.

This award supersedes the Army Commendation Medal awarded by the Commander, 1st Infantry Division (Mechanized) and Fort Riley, Fort Riley, Kansas, , under the provisions of paragraph 7a, AR 672-5-1, to Specialist Smith.

**IV--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" device for heroism in connection with military operations against hostile forces is awarded to:

Sergeant First Class *Tito C. Labra*, , United States Army, for action on 19 September 1970.

Staff Sergeant *Julius Maynard*, , United States Army, for action on 24 August 1962. This award is authorized under the provisions of paragraph 11c, AR 672-5-1.

Staff Sergeant *Garfield Thomas*, , United States Army, for action on 11 June 1969. This award is authorized under the provisions of paragraph 11c, AR 672-5-1.

**V--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" device (First Oak Leaf Cluster) for heroism in connection with military operations against hostile forces is awarded to:

Sergeant First Class *Tito C. Labra*, , United States Army, for action on 23 November 1970.

**VI--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious service in connection with military operations against hostile forces is awarded to:

Special Group Captain Navy *Maharaghkaga*, , Royal Thai Air Force, July 1970 to July 1971.

**VII--ARMY COMMENDATION MEDAL.** By direction of the Secretary of the Army, under the provisions of paragraph 33, AR 672-5-1, the Army Commendation Medal for meritorious service, on dates as indicated, is awarded to:

Captain *Durval A. Nery*, , Army of Brazil, April 1972 to May 1973.

Major *Duong Quang Le*, , Vietnamese Air Force, July 1971 to June 1972.
