**I. GENERAL COURTS-MARTIAL:** Confirming verbal orders of the Secretary of the Army of 1 July 1974, the Commanding General, United States Army Garrison Okinawa (Prov.), W3K4AA-A, APO San Francisco 96331, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial effective 1 July 1974.

**II. CAMP McCoy, WISCONSIN.** Effective 30 September 1974, Camp McCoy, Wisconsin, a semiactive installation under the jurisdiction of the Commander, US Army Forces Command, is redesignated as Fort McCoy.

**III. CAMP DRUM, NEW YORK.** Effective 30 September 1974, Camp Drum, New York, a semiactive installation under the jurisdiction of the Commander, US Army Forces Command, is redesignated as Fort Drum.

**IV. CAMP A. P. HILL, VIRGINIA.** Effective 30 September 1974, Camp A. P. Hill, Virginia, a semiactive installation under the jurisdiction of the Commander, US Army Training and Doctrine Command, is redesignated as Fort A. P. Hill.

**V. CAMP PICKETT, VIRGINIA.** Effective 30 September 1974, Camp Pickett, Virginia, a semiactive installation under the jurisdiction of the Commander, US Army Training and Doctrine Command, is redesignated as Fort Pickett.

**VI. JUNIOR ROTC UNIT.** Effective beginning school year 1974-75, the name and address of Murray F. Tuley High School, 1313 N. Claremont, Chicago, Illinois, was changed to Roberto Clemente High School, 1147 North Western Avenue, Chicago, Illinois 60622.

**VII. JUNIOR ROTC UNITS.** Effective 1 August 1974, Junior ROTC units were disestablished at the following high schools:

Mumford High School, Detroit, Michigan  
Northern High School, Detroit, Michigan  
Pershing High School, Detroit, Michigan  
Southwestern High School, Detroit, Michigan
