I. SALINAS TRAINING SITE. Effective 1 July 1975 the Salinas Training Site near Salinas, Puerto Rico is renamed Camp Santiago in honor of Specialist Four Hector Santiago-Colon who was awarded the Congressional Medal of Honor posthumously for distinguishing himself by conspicuous gallantry while serving with Co B, 5th Battalion, 7th Cavalry in the Republic of Vietnam.

II. GENERAL COURTS-MARTIAL. Confirming verbal orders of the Secretary of the Army of 3 September 1975, the Commander, 7th Infantry Division and Fort Ord, Fort Ord, California 93941, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial effective 21 September 1975.

III. UNITED STATES ARMY COURIER STATION—TEHRAN. Effective 1 November 1975, the United States Army Courier Station—Tehran is established as a field operating activity under the Commanding General, The Adjutant General Center.

IV. JUNIOR ROTC UNIT. Effective 15 August 1975, a Junior ROTC unit was established at Wenonah High School, Birmingham, Alabama.
