- I\_GENERAL COURTS-MARTIAL. Effective 16 September 1977 all Department of the Army personnel assigned, attached, or on duty in Republic of China, Taiwan, not otherwise specifically attached to any command for general court-martial jurisdiction, are attached to United States Army, Japan for the exercise of general court-martial jurisdiction.
- II.\_FORT BUCHANAN, PUERTO RICO. Effective 1 October 1977, Fort Buchanan, Puerto Rico, an active installation under the Command jurisdiction of the Commanding General, US Army Forces Command is designated as a subinstallation of Fort McPherson, Georgia.
- III\_NATIONAL DEFENSE CADET CORPS UNIT. Effective 1 September 1977, a NDCC unit was established at Western Harnett High School, Lillington, North Carolina.
- IV\_JOINT INTEROPERABILITY OF TACTICAL COMMAND AND CONTROL SYSTEMS—JOINT INTERFACE TEST FORCE. Effective 1 August 1977, the Ground and Amphibious Military Operations Joint Interpoperability Test Force (GAMO-JITF) (SFW36BAA) is redesignated as the Joint Interoperability of Tactical Command and Control Systems Joint Interface Test Force (JINTACCS-JITF) and is relocated from Washington, DC to Fort Monmouth, NJ. The unit remains a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans, HQDA. The Commanding General, US Army Electronics Command, Fort Monmouth, NJ will exercise General Courts-Martial jurisdiction over the unit.
- V.\_JUNIOR ROTC UNIT. Palatka South High School, Palatka, Florida was redesignated Palatka High School, Palatka, Florida on 15 July 1977.
- VI\_JUNIOR ROTC UNIT. The name of Sanford Central High School, Sanford, North Carolina was changed to Lee County Senior High School, Sanford, North Carolina on 27 July 1977.
