I. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Sergeant *Herman D. Adelstein*, RA 564934, United States Army, for action in October 1918, during World War I in Bois de Briuelles, France. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Captain *Daniel J. Boccolucci*, , (then First Lieutenant), Infantry, United States Army, for action on 10 December 1970, while a member of Company D, 1st Battalion, 52d Infantry, 23d Infantry Division, Republic of Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Staff Sergeant *Dennis L. Gauthier*, , (then Private First Class), United States Army, for action on 31 October 1969, while a member of Company C, 3d Battalion, 12th Infantry, 4th Infantry Division, Republic of Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II. LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

General Doctor *Karl Schnell*, , Army of the Federal Republic of Germany, 1 October 1973 to 31 December 1976.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Major General *Marc A. Cauchie*, French Army, June 1960 to August 1976.

Major General *Guy G. V. Maracal de Bonneray*, French Army, 20 October 1973 to 30 June 1976.

Brigadier General *Park Choon Shik*, , Republic of Korea Army, 28 July 1975 to 17 January 1977.

Admiral *Luigi Tomasuolo*, Italian Navy, from June 1975 to June 1977.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Colonel *Pierre F. Beque*, , French Army, 2 September 1974 to 28 July 1976.

Lieutenant Colonel *Dieter J. Dohm*, Army of the Federal Republic of Germany, October 1973 to September 1976.

III...DISTINGUISHED FLYING CROSS. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to:

Specialist Five *James H. Buchanan*, , United States Army, for action from 18 August 1968 to 21 August 1968, while a member of the 57th Helicopter Assault Company, 52d Aviation Battalion, 1st Aviation Brigade.

IV...SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Major *Erik J. Mason*, , Adjutant General's Corps, United States Army, for heroism on 10 April 1977, while a member of the United States Military Group-Bolivia.

Captain *George J. Nepereny*, , Transportation Corps, United States Army, for heroism on 27 November 1976, while a member of the US Army Aviation Engineering Flight Activity, Edwards Air Force Base, California.

V...ARMY COMMENDATION MEDAL. 1. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:

Lieutenant Colonel *Tamoyo Pereira das Neves*, Army of Brazil, 31 January 1975 to 26 February 1977.

Major *Wolfgang Feise*, , Army of the Federal Republic of Germany, 1 April 1973 to 31 July 1977.

Lieutenant Colonel *Jose G. Lock Figueroa*, Army of Peru, 27 December 1975 to 27 December 1976.

Sergeant Major *Peter K. Fischbach*, , Army of the Federal Republic of Germany, 28 September 1970 to 30 September 1976.

Major *Rudiger K. V. Janke*, , Army of the Federal Republic of Germany, 1 April 1973 to 6 April 1977.

Major *Detlef W. Jungmann*, , Army of the Federal Republic of Germany, 1 November 1972 to 19 May 1977.

Captain *Joachim A. Marks*, , Army of the Federal Republic of Germany, 1 October 1972 to 1 April 1977.

Master Sergeant *Heinrich Rey*, , Army of the Federal Republic of Germany, 15 November 1969 to 31 March 1977.

First Sergeant *Harold Sulzer*, , Army of the Federal Republic of Germany, 1 July 1974 to 12 October 1976.

2. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-51-1, the Army Commendation Medal (First Oak Leaf Cluster) for meritorious service is awarded to:

Major *Norman E. Stark*, Army of Paraguay, 12 December 1975 to 12 December 1976.

VI...DISTINGUISHED SERVICE CROSS. So much of Section IV, General Orders Number 19, 1974, Headquarters, Department of the Army, pertaining to award of the Distinguished Service Cross to Captain (then First Lieutenant) *Joseph W. Eszes*, 255-68-4067, Field Artillery, United States Army, as reads "for action on 6 December 1971," is amended to read "for action on 9 December 1971."
