I. FRANKFORD ARSENAL, PENNSYLVANIA. Effective 1 October 1977, Frankford Arsenal, an active Army installation under the command jurisdiction of the Commanding General, US Army Materiel Development and Readiness Command, is placed in an inactive status.

II. NEWPORT ARMY AMMUNITION PLANT, INDIANA. Effective 18 April 1974, Newport Army Ammunition Plant, an active Army installation under the command jurisdiction of the Commanding General, US Army Materiel Development and Readiness Command, was placed in an inactive status.

III. DEPOTS AND DEPOT ACTIVITIES (DARCOM). The following depots and depot activities, under the command jurisdiction of the Commanding General, US Army Materiel Development and Readiness Command, were redesignated and/or reassigned as follows:

2. **UMATILLA ARMY DEPOT, OREGON.** Effective 24 August 1973, Umatilla Army Depot was redesignated as Umatilla Depot Activity and assigned to Tooele Army Depot, Utah, as a subinstallation.

3. **FORT WINGATE DEPOT ACTIVITY, NEW MEXICO.** Effective 28 September 1975, Fort Wingate Depot Activity, a subinstallation of Pueblo Army Depot, Colorado, was reassigned as a subinstallation of Tooele Army Depot, Utah.

4. **NAVAJO DEPOT ACTIVITY, ARIZONA.** Effective 28 September 1975, Navajo Depot Activity, a subinstallation of Pueblo Army Depot, Colorado, was reassigned as a subinstallation of Tooele Army Depot, Utah.

5. **PUEBLO ARMY DEPOT, COLORADO.** Effective 1 July 1976, Pueblo Army Depot was redesignated as Pueblo Depot Activity and assigned as a subinstallation of Tooele Army Depot, Utah.

6. **SAVANNA ARMY DEPOT, ILLINOIS.** Effective 1 July 1976, Savanna Army Depot was redesignated as Savanna Depot Activity and assigned as a subinstallation of Letterkenny Army Depot, PA.

7. **LEXINGTON—BLUE GRASS ARMY DEPOT, KENTUCKY.** Effective 24 July 1977, Lexington—Blue Grass Army Depot was redesignated as Lexington—Blue Grass Depot Activity and assigned as a subinstallation of Red River Army Depot, Texas."
