I. SENIOR ROTC UNIT. So much of paragraph title of DA General Orders 17, 13 October 1977, as reads "JUNIOR ROTC UNIT" is amended to read "SENIOR ROTC UNIT."

II. JUNIOR ROTC UNITS. 1. Effective 29 September 1977, the following Junior ROTC units were disestablished:

Coolidge High School, Washington, DC

Woodrow Wilson Senior High School, Washington, DC

2. Effective 1 September 1977, the Junior ROTC unit at Youngstown Public School, Youngstown, Ohio was disestablished.

III. US ARMY INTELLIGENCE SYSTEMS SUPPORT AGENCY (UIC W3HEAA, TPSN 46555). Effective 22 January 1978, the US Army Intelligence Systems Support Agency (UIC W3HEAA, TPSN 46555), will be discontinued. This unit will be released from the Office, Assistant Chief of Staff for Intelligence, Washington, DC 20310.

Operations and systems development functions and associated manpower authorizations will be transferred to Headquarters, US Army Intelligence and Security Command (INSCOM), Arlington Hall Station, Arlington, VA 22212, effective 22 January 1978. Personnel will remain in the Pentagon, no travel will be involved.

Intelligence Data Handling System and Automation Security planning, programing, and policy functions and manpower authorizations associated with the functions will be transferred to the Intelligence Automation Management Office of the Office, Chief of Staff for Intelligence (UIC WOZ1AA). Personnel will remain in the Pentagon, no travel will be involved.
