I—OFFICE OF THE ASSISTANT CHIEF OF STAFF FOR AUTOMATION AND COMMUNICATIONS, US ARMY (CSW4DGAA). Effective 1 October 1978, the Office of the Assistant Chief of Staff for Automation and Communications is established as a General Staff Agency of the Headquarters, Department of the Army.

II—ARMY AUTOMATION DIRECTORATE, OCSA. Effective 1 October 1978, the Army Automation Directorate, OCSA, is discontinued. Concurrently, functions personnel and equipment will be distributed in accordance with existing requirements and regulations.

III——TELECOMMUNICATIONS AND COMMAND AND CONTROL DIRECTORATE, ODCSOPS, US ARMY. Effective 1 October 1978, the Telecommunications and Command and Control Directorate, ODCSOPS, US Army, is discontinued. Concurrently, functions, personnel, and equipment will be distributed in accordance with existing requirements and regulations.

- IV—UNITED STATES ARMY COMPUTER SYSTEMS COMMAND (CMW248AA). 1. Effective 1 October 1978, the United States Army Computer Systems Command, a field operating agency under the jurisdiction of the Director, Army Automation, OCSA, is transferred, under the jurisdiction of the Assistant Chief of Staff for Automation and Communications.
- 2. The United States Army Computer Systems Command includes the following subordinate elements—
- a. US Army Computer Systems Command Support Group Pacific (CMW3ADAA).
- b. US Army Computer Systems Command Support Group Europe (CMW 3AEAA).
- c. US Army Computer Systems Command Support Group Ft Lee (CMW3BDAA).
- d. US Army Research and Development Information Systems Agency (CMWOLAAA).
- V——UNITED STATES ARMY COMPUTER SYSTEMS SELECTION AND ACQUISITION AGENCY (CMW 2 Y2AA). Effective 1 October 1978, the United States Army Computer Systems Selection and Acquisition

Agency, a field operating agency under the jurisdiction of the Director, Army Automation, OCSA, is transferred, as a field operating agency under the jurisdiction of the Assistant Chief of Staff for Automation and Communication.

VI—UNITED STATES ARMY MANAGEMENT SYSTEMS SUP-PORT AGENCY (SFW1SEAA). Effective 1 October 1978, the United States Army Management Systems Support Agency, a staff support agency under the jurisdiction of the Director of Army Automation, OCSA, is transferred, as a staff support agency under the jurisdiction of the Assistant Chief of Staff for Automation and Communications.

VII—JOINT INTERFACE TEST FORCE—JINTACCS (SFW36BAA). Effective 1 October 1978, the Joint Interface Test Force—JINTACCS, a field operating agency under the jurisdiction of the Deputy Chief of Staff of Operations and Plans, is transferred, as a field operating agency under the jurisdiction of the Assistant Chief of Staff for Automation and Communications.
