V. . . HOLABIRD DEFENSE INVESTIGATION FACILITY, BALTIMORE, MD. Effective 1 September 1979, the active area (14.92 acres) of Fort Holabird, Maryland, an inactive excess subinstallation of Fort George G. Meade, Maryland, is designated as Holabird Defense Investigation Facility, an active subinstallation of Fort George G. Meade, Maryland.
