**I. . . GENERAL COURTS-MARTIAL.** The Commander, United States Army Garrison, Okinawa, APO San Francisco 96331, is designated by the Secretary of the Army pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial effective 25 September 1979.

**II. . . U.S. ARMY CHAPLAIN BOARD.** On 23 July 1979, the U.S. Army Chaplain Board transferred from Fort Wadsworth, NY to Fort Monmouth, NJ 07703.

**III. . . JUNIOR ROTC UNIT.** 1. Effective 26 July 1979, the Junior ROTC unit at Dreher High School, Columbia, SC was disestablished.

2. Effective 30 June 1979, The Junior ROTC unit at Eastern Military Academy, Huntington (LI), New York was disestablished.

**IV. . . NATIONAL DEFENSE CADET CORPS UNIT.** Effective 30 June 1979, the NDCC unit at Highland Park High School, Dallas, TX was disestablished.

**V. . . JUNIOR ROTC UNIT.** 1. Effective 21 August 1979, the name of John Marshall High School, Richmond, VA 23227 was changed to Marshall-Walker High School Complex, Richmond, VA 23227.

2. Effective 30 June 1979, the name of McCreary County High School, Whitley City, KY 42653 was changed to McCreary Central High School, Whitley City, KY 42653.

**VI. . . SPECIAL COURTS-MARTIAL.** The Commander, United States Army Infantry Division Forward Rotational Base Unit, APO New York 09137, is designated by the Secretary of the Army pursuant to the Uniform Code of Military Justice, Article 23(a)(7), to convene special courts-martial effective 15 October 1979.
