VALOROUS UNIT AWARD—AMENDMENT I
 MERITORIOUS UNIT COMMENDATION—AMENDMENTS I
 VIETNAMESE CROSS OF GALLANTRY—AMENDMENT AND REVOCATIONIII

I. . . VALOROUS UNIT AWARD. So much of Section I, General Orders Number 43, 1972, Headquarters, Department of the Army, Washington, DC, as pertains to award of the Valorous Unit Award to the 1st Cavalry Division and its assigned and attached units as reads: Company D, 3d Squadron, 17th Cavalry, is amended to read: Troop D, 3d Squadron, 17th Cavalry.

II. . . MERITORIOUS UNIT COMMENDATION. 1. So much of Section II, General Orders Number 66, 1968, Headquarters, Department of the Army, Washington, DC, as pertains to award of the Meritorious Unit Commendation to the 25th Aviation Battalion and attached units as reads: 341st Airfield Operations Detachment during the period, 2 April 1966 to 31 December 1967 as amended by Section IV, General Orders Number 43, 1969, to read: 2 April 1966 to 31 December 1966 is further amended to read: 341st Aviation Detachment.

2. So much of Paragraph 6, Section II, General Orders Number 75, 1969, Headquarters, Department of the Army, Washington, DC, as pertains to award of the Meritorious Unit Commendation to the 406th Medical Laboratory, United States Army Medical Command, Japan, as reads: for the period May 1965 through May 1969, is amended to read: August 1965 to May 1969.

III. . . VIETNAMESE CROSS OF GALLANTRY WITH PALM (SECOND AWARD). 1. So much of Paragraph 2, Section III, Department of the Army General Orders Number 21, 1969, Headquarters, Washington, DC, pertaining to award of the Vietnamese Cross of Gallantry with Palm (Second Award) to the 1st Aviation Brigade and its assigned and attached units as reads: 10th Aviation Battalion, 14th Aviation Battalion and 52d Aviation Battalion is amended to read as follows: "Headquarters and Headquarters Detachment, 10th Aviation Battalion", "Headquarters and Headquarters Detachment, 14th Aviation Battalion" and "Headquarters and Headquarters Company, 52d Aviation Battalion" for the period 27 March 1967 to 17 May 1968.

2. So much of Paragraph 19, Section VIII, Department of the Army General Orders 43, 1970, Headquarters, Washington, DC, pertaining to award of the Vietnamese Cross of Gallantry with Palm (Second Award) to the 1st Aviation Brigade and its assigned and attached units is revoked.
