**I. DISTINGUISHED SERVICE CROSS.** By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded to:

Colonel *Walter T. Collins*, , United States Marine Corps (then Private, United States Army) distinguished himself by extraordinary heroism on 15 July 1918 while serving as a sniper with the 1st Battalion, 165th United States Infantry in Jonchery, France during the Champagne Defensive. Colonel Collins was the first to respond to a call for volunteers to carry a message through open terrain swept by machine gun fire and a heavy artillery bombardment of high explosives and gas shells. Although badly gassed, and at one time knocked down by the concussion of high explosive shells, Colonel Collins rescued two wounded comrades, carrying each in turn through the heavy bombardment to a position of safety in the town of Jonchery. Severely gassed during the perilous mission, and nearly exhausted from his efforts in rescuing his wounded comrades, Colonel Collins, nevertheless, refused all medical aid until he delivered his message. His splendid courage and resourcefulness materially aided in consolidating the unit position without further losses. Colonel Collins' selfless actions were in keeping with the highest traditions of military service and reflect great credit upon him, the 165th Infantry and the United States Army. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**II. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Private First Class *Ralph L. Schwartz*, , United States Army, for action near Tillet, Belgium, on 26 January 1945, while a member of Company E, 3d Battalion, 46th Infantry Regiment, 87th Infantry Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**III. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Major *Kenneth J. Yonan*, (then Captain), Infantry, United States Army, for action on 23 April 1972, while a member of Advisory Team 22, United States Military Assistance Command, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**IV. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Major *David R. Dickerson*, (then Captain) United States Army Reserve, for action from 22 to 24 June 1971, while a member of United States Army Advisory Group, I Corps and Military Region 1 (Team 3), United States Military Assistance Command, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**V. LEGION OF MERIT. 1.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Lieutenant General *Rafael Eitan*, Army of Israel, April 1978 to November 1979.

This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**VII. DISTINGUISHED FLYING CROSS.** By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Distinguished Flying Cross for extraordinary heroism while participating in aerial flight is awarded posthumously to:
