**I. UNITED STATES ARMY ELEMENT, JOINT ELECTRONIC WARFARE CENTER.** Section I, Department of the Army General Orders 6, 13 March 1979, is amended as follows:

a. Paragraph 2, first sentence: Delete the words "Commandant, Air Force" and substitute therefor the words "Director, Joint."

*Reason:* Reflects change in operational control of US Army Element, Joint Electronic Warfare Center, from Commandant, Air Force Electronic Warfare Center to the recently established position of Director, Joint Electronic Warfare Center (JEWEC). The JEWEC was established on 1 October 1980. Authority: JCS SM 464-80.

b. Paragraph 3: Delete the words "including the administration of nonjudicial punishment, Article 15, UCMJ."

*Reason:* Senior Army member at US Army Element, JEWEC, now of appropriate rank to administer such punishment.

**II. SENIOR ROTC UNIT.** 1. Effective 1 October 1980, a Senior ROTC unit will be established at Bemidji State University, Bemidji, Minnesota.

2. Effective 15 January 1981, a Senior ROTC unit will be established at University of Southern California, Los Angeles, California.

**III. JUNIOR ROTC UNIT.** Effective 1 April 1981, a Junior ROTC unit will be established at Bowman High School, Wadesboro, North Carolina 28170.

**IV. JUNIOR ROTC UNIT.** 1. Effective 19 December 1980, the name of the Junior ROTC unit which was established at Havana High School, Havana, Florida was changed to Havana Northside High School, Havana, Florida 32333.

2. Effective 1 September 1979, the name of the Junior ROTC unit which was established at Houston Technical Institute, Houston, Texas was changed to Barbara Jordan Technical Institute, 5800 Eastex Freeway, Houston, Texas 77026.

3. Effective 5 January 1981, the name of the Junior ROTC unit which was established at Toulminville High School, Mobile, AL was changed to John L. LeFlore High School, Mobile, AL 36633.
