I—SILVER STAR. 1. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Private *John R. Flores*, , United States Army, for heroism in March 1944, while a member of the 88th Infantry Division, Italy. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

Sergeant (then Private First Class) *Keith A. Loso*, , United States Army, for action on 13 January 1967, while a member of Troop I, 3d Squadron, 11th Armored Cavalry Regiment, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

2. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star (Second Oak Leaf Cluster) is awarded to:

Lieutenant Colonel (then Captain) *Sammy E. Radow*, , Infantry, United States Army, for heroism on 28 February 1951, while a member of Headquarters Company, 1st Battalion, 23d Infantry Regiment, 2d Infantry Division, Korea. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

3. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star (Third Oak Leaf Cluster) is awarded to:

Lieutenant Colonel (then Captain) *Sammy E. Radow*, , Infantry, United States Army, for heroism on 20 April 1951, while a member of Headquarters Company, 1st Battalion, 23d Infantry Regiment, 2d Infantry Division, Korea. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

II—LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

Major General *Fortunato U. Abat*, , Philippine Army, 26 March 1976 to 27 March 1981.

Major General *Boubaker Ben Mohamed Balma*, Tunisian Army, 11 February 1974 to 31 March 1981.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

Colonel *Hans Claus Hanneman*, , Army of the Federal Republic of Germany, 1 May 1976 to 20 August 1980.

Colonel *Kim Sang Kil*, , Republic of Korea Army, 31 May 1978 to 7 April 1980.

Colonel *Helmut Vieweg*, , Air Force of the Federal Republic of Germany, 1 October 1977 to 30 September 1980.

III—DISTINGUISHED FLYING CROSS. 1. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer (then Warrant Officer) *George A. Grady*, United States Army, for heroism on 1 February 1971, while a member of Company A, 229th Assault Helicopter Battalion, 1st Cavalry Division, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

2. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism, not involving actual conflict with an enemy, while participating in aerial flight is awarded by the Department of the Army to:

Captain *Jesse C. Hagerman*, , Armor, Washington Army National Guard, for heroism on 18 and 19 May 1980, while a member of Headquarters and Headquarters Company, 81st Infantry Brigade, Seattle, Washington.

IV—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant *Marc A. Baker*, , United States Army, for heroism on 5 March 1971, while a member of the 116th Assault Helicopter Company, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

Staff Sergeant (then Sergeant) *Michael L. Coffey*, , United States Army, for heroism on 14 August 1979, while a member of Company C, 4th Battalion 54th Infantry (Mechanized), Fort Knox, Kentucky.

Sergeant *Randy A. Fantz*, , Washington Army National Guard, for heroism on 18 May 1980, while a member of Headquarters and Headquarters Company, 81st Infantry Brigade, Seattle, Washington.

Staff Sergeant *Calvin C. Fernstrum*, , United States Army, for heroism on 7 March 1981, while a member of United States Army Field Station Kunia, Wheeler Air Force Base, Hawaii.

First Sergeant *Walter D. Higginbotham*, , United States Army, for heroism on 16 October 1980, while a member of B Battery, 6th Battalion, 33rd Field Artillery, Fort Sill, Oklahoma.

Sergeant First Class (then Specialist Six) *Donald R. Hohman*, , United States Army, for heroism on 6 February 1980, while a member of the 97th General Hospital, US Army Europe.

Sergeant First Class *Joel A. Komrosky*, , United States Army, for heroism on 1 November 1980, while a member of 1st Battalion

(Airborne), 505th Infantry, 82d Airborne Division, Fort Bragg, North Carolina.

Staff Sergeant *Cleveland Marsh*, , United States Army, for heroism on 25 November 1980, while a member of Basic Training Committee Group, United States Army Training Center and Fort Dix, Fort Dix, New Jersey.

Staff Sergeant *Jimmy H. Roberson*, , United States Army, for heroism on 21 September 1980, while a member of A Battery, 2d Battalion, 5th Field Artillery, Germany.

Sergeant First Class *William D. Scanlan*, , United States Army, for heroism on 16 December 1979, while a member of Company B, 3d Battalion 5th Infantry, Fort Kobbe, Panama.

Specialist Five *Randy W. Smith*, , United States Army, for heroism on 18 September 1980, while a member of United States Army Cold Regions Test Center, Fort Greely, Alaska.

Private *Michael E. Strutt*, , United States Army, for heroism on 4 November 1980, while a member of A Company, 3d Battalion, 32d Armor, Germany.

Sergeant *James E. Thigpen*, , United States Army, for heroism on 7 March 1981, while a member of United States Army Field Station Kunia, Wheeler Air Force Base, Hawaii.

Specialist Five *Richard C. Wiggins*, , United States Army, for heroism on 22 November 1980, while a member of 68th Medical Detachment, 25th Infantry Division, Schofield Barracks, Hawaii.

Sergeant First Class (then Staff Sergeant) *Walter R. Willhide*, , United States Army, for heroism on 5 March 1971, while a member of the 116th Assault Helicopter Company, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

V—BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal (First Oak Leaf Cluster) with "V" Device for heroism in connection with military operations against hostile forces is awarded to:

Master Sergeant (then Staff Sergeant) *Marshall C. Huckaby*, , United States Army for heroism on 13 January 1969 while a member of the 224th Aviation Company, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

VI—AIR MEDAL. 1. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal for heroism not involving actual conflict with an enemy, while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer *Harold R. Kolb*, , Washington Army National Guard, for heroism on 18 May 1980, while a member of Attack Helicopter Troop, 116th Armored Cavalry Regiment, Camp Murray, Washington.

2. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (Second Award) for heroism not involving actual conflict with an enemy, while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer Two *Michael D. Cairns*, , Washington Army National Guard, for heroism on 18 May 1980, while a member of Attack Helicopter Troop, 116th Armored Cavalry Regiment, Camp Murray, Washington.

3. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (Twenty-first Award) for heroism not involving actual conflict with an enemy, while participating in aerial flight is awarded by the Department of the Army to:

Captain *Francis F. Shipton*, , Infantry, Washington Army National Guard, for heroism on 18 May 1980, while a member of Attack Helicopter Troop, 116th Armored Cavalry Regiment, Camp Murray, Washington.

4. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (Thirty-third Award) for heroism not involving actual conflict with an enemy, while participating in aerial flight is awarded by the Department of the Army to:

Captain *Donald R. Stebner*, , Infantry, Washington Army National Guard, for heroism on 18 May 1980, while a member of Attack Helicopter Troop, 116th Armored Cavalry Regiment, Camp Murray, Washington.

VII—ARMY COMMENDATION MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:
