I—LEGION OF MERIT. By direction of the President, under the provisions of the Act of Congress approved on 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded posthumously to:

Colonel *Franz Greiner*, , Army of the Federal Republic of Germany, 1 October 1977 to 3 April 1981.

II—LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

Brigadier General *Jobst Arthur Hermann Von Capelle*, , Army of the Federal Republic of Germany, 1 October 1977 to 1 March 1981.

Major General *Guillermo Schroth Carlin*, Army of Peru, February 1980 to February 1981.

Colonel *German T. Domingo*, the Philippine Army. November 1972 to February 1981.

Major General *Armando Orejuela Escobar*, Army of Colombia, July 1979 to February 1981.

Brigadier General *Guenter Wolfgang Kriebel*, , Army of the Federal Republic of Germany, 1 October 1976 to 15 May 1981.

Brigadier General *Abukar Mohamed Liban*, Army of Somalia, June 1979 to February 1981.

Colonel *Ruperto Clodoaldo Pinto*, Army of Brazil, February 1980 to April 1981.

Colonel Doctor *Hans-Karl Ueberle*, , German Army of Defense, 1 April 1975 to 30 September 1980.

Brigadier General *Enno Walter*, Army of the Federal Republic of Germany, 1 July 1978 to 30 September 1981.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

Colonel Barøn *Busso Von Berlepsch*, , Army of the Federal Republic of Germany, 1 October 1978 to 30 September 1981.

III—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving conflict with an enemy is awarded posthumously to:

Captain *Gregory E. Gardner*, , Medical Corps, United States Army, for heroism on 21 September 1981, while a member of the 2d Battalion (Ranger), 75th Infantry, Fort Lewis, Washington.

IV—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved by 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private (E2) *Roger C. Anderson*, , United States Army, for heroism on 16 October 1980, while a member of Battery C, 2d Battalion, 36th Field Artillery, Fort Sill, Oklahoma.

Staff Sergeant *Billy F. Burnham*, , United States Army, for heroism on 16 October 1980, while a member of Battery C, 2d Battalion, 36th Field Artillery, Fort Sill, Oklahoma.

Sergeant *Faitala, Faitala Jr.*, , United States Army, for heroism on 15 March 1981, while a member of C Company, 1st Battalion (Mechanized), 31st Infantry, 2d Infantry Division, Korea.

Specialist Four *Donald A. Heath*, , United States Army, for heroism, on 7 November 1980, while a member of 56th Signal Company, 509th Signal Battalion, Camp Darby, Leghorn, Italy.

Specialist Four *James E. Little*, , United States Army, for heroism on 17 July 1980, while a member of Company A, 159th Aviation Battalion, 101st Airborne Division (Air Assault), Fort Campbell, Kentucky.

First Sergeant *Donald W. Maddox*, , United States Army, for heroism on 16 October 1980, while a member of Battery C, 2d Battalion, 36th Field Artillery, Fort Sill, Oklahoma.

Sergeant *Bruce W. Matthews*, , United States Army, for heroism on 15 September 1981, while a member of the 529th Military Police Company, 26th Support Group, Germany.

Sergeant *Joseph D. Nation*, , United States Army, for heroism on 29 June 1981, while a member of Headquarters and Headquarters Company (Provisional), Ft. Chaffee, Arkansas.

Lieutenant Colonel *Richard A. Pack*, , Infantry, United States Army, for heroism on 21 September 1981, while a member of Joint Special Operations Command, Fort Bragg, North Carolina.

Private First Class *Stephen M. Pedigo*, , United States Army, for heroism on 7 November 1980, while a member of the 56th Signal Company, 509th Signal Battalion, Camp Darby, Leghorn, Italy.

Sergeant *James A. Pierson*, , United States Army, for heroism on 15 March 1981, while a member of C Company, 1st Battalion (Mechanized), 31st Infantry, 2d Infantry Division, Korea.

Specialist Four *Michael V. Rountree*, , United States Army, for heroism on 29 April 1981, while a member of Headquarters Company, 1st Battalion, 9th Infantry, 2d Infantry Division, Korea.

Sergeant *Donnie W. Ruff*, , United States Army, for heroism on 27 July 1981, while a member of Basic Training Committee Group, United States Army Military Police and Chemical Schools/Training Center and Fort McClellan, Alabama. (This award supersedes the Army Commendation Medal awarded to Sergeant Donnie W. Ruff for heroism on 27 July 1981, as announced in Permanent Orders 52-1, Department of the Army, United States Army Military Police and Chemical Schools/Training Center and Fort McClellan, Fort McClellan, Alabama 36205, 11 August 1981).

Specialist Four *Marvin D. Talley*, , United States Army, for heroism on 15 September 1981, while a member of the 529th Military Police Company, 26th Support Group, Germany.

Sergeant *Paul J. Williams*, , United States Army, for heroism on 7 May 1981, while a member of Company B, 1st Battalion, 7th Special Forces Group (Airborne), Fort Bragg, North Carolina.

V—ARMY COMMENDATION MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:

Lieutenant Colonel *Masuhiko Takahashi*, , Japan Ground Self Defense Force, 1 July 1965 to 1 July 1981.

Lieutenant Colonel *Jose G. Villanueva*, , Peruvian Army, 1 February 1980 to 31 January 1981.

VI—MERITORIOUS UNIT COMMENDATION. By direction of the Secretary of the Army, under the provisions of paragraph 9-20, AR 672-5-1, the Meritorious Unit Commendation (First Oak Leaf Cluster) is awarded to the following unit of the Armed Forces of the United States for exceptionally meritorious achievement in the performance of outstanding service during the period indicated:

The United States Military Liaison Mission to the Commander in Chief, Group of Soviet Forces in Germany, during the period 2 August 1976 through 31 December 1980.

VII—SILVER STAR. So much of section IV, General Orders 26, 1981, Headquarters, Department of the Army, Washington, DC, as pertains to the award of the Silver Star to Corporal (then Private First Class) *Jordan M. Robinson*, United States Army, as reads: "Jordan H. Robinson" is amended to read "Jordan M. Robinson."

VIII—LEGION OF MERIT. So much of paragraph 2, section I, General Orders Number 23, 1981, Headquarters, Department of the Army, Washington, DC, as pertains to the award of the Legion of Merit (Degree of Officer) to Major General *Fritz von Westerman*, Army of the Federal Republic of Germany, as reads: "Major General Fritz von Westermann" is amended to read "Major General Fritz von Westerman."

IX—BRONZE STAR MEDAL. So much of section VIII, General Orders 26, 1981, Headquarters, Department of the Army, Washington, DC, as pertains to the award of the Bronze Star Medal with "V" Device to Corporal (then Private First Class) *Robert M. Preston*, United States Army, as reads: "Robert H. Preston" is amended to read "Robert M. Preston."

X—PRESIDENTIAL UNIT CITATION. So much of section I, General Orders Number 42, 1969, Department of the Army, Washington, DC, as amended by Section X, General Orders Number 5, 1979, Department of the Army, Washington, DC, as pertains to the award of the Presidential Unit Citation to the 173d Airborne Brigade (Separate) and its assigned and attached units is amended to add: 4th Battalion, 503d Infantry.

XI—FOREIGN DECORATIONS. So much of Department of the Army General Orders 43, 19 December 1950, pertaining to section II, paragraph 4a is amended to add the following:

“704th Tank Destroyer Battalion (Attached to 4th Armored Div)
