I—SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to—

Sergeant Major (then Sergeant) *Robert W. Chaplin, Sr.*, United States Army, for action on 15 September 1966, while a member of Operational Detachment A-502, 5th Special Forces Group (Abn), 1st Special Forces, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II—LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

General *Lee Hui-sung*, Republic of Korea Army, December 1979 to November 1981.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—
