I—SILVER STAR. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded to—

Staff Sergeant *James C. Donahue, Jr.*, , United States Army, for heroism on 19 July 1967, while a member of Detachment A-303, 5th Special Forces Mobile Guerrilla Force, Vietnam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

II—LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

General *Jean-Yves Lionel Delaunay*, Army of France, October 1980 to June 1982.

Major General *Josephus Q. Ramas*, Philippine Army, March 1981 to April 1982.

General *Hwang Yung Si*, Republic of Korea Army, December 1981 to July 1982.

Lieutenant General *Edmond L. M. De Wilder*, Belgium Army, April 1981 to July 1982.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Brigadier General *Armand Jean Marie Troquet*, Army of France, January 1979 to October 1981.

Brigadier General *Ramon Benigno Aguilar Sanchez*, Venezuelan Army, September 1980 to May 1982.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Colonel *Juergen Molsen*, Army of the Federal Republic of Germany, 11 September 1979 to 30 September 1982.

III—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to—

Private First Class *Robert G. Solonika*, , United States Army, for heroism on 24 January 1982 while a member of Company B, 1st Battalion, 18th Infantry, 1st Infantry Division, Fort Riley, Kansas.

IV—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to—

Specialist Four *James W. Black, Jr.*, , United States Army, for heroism on 3 March 1982, while a member of the North Atlantic Treaty Organization/Supreme Headquarters, Allied Powers Europe Support Group, Belgium.

Specialist Four *Douglas R. Chapman*, , United States Army Reserve, for heroism on 5 July 1980, while a member of Company B, 1st Battalion, 410th Infantry, 3440 North Division Street, Davenport, Iowa.

Sergeant First Class *David R. Gibson*, , United States Army, for heroism on 3 March 1982, while a member of United States Army Element, Supreme Headquarters, Allied Powers Europe, Belgium.

Specialist Four *Arnold Guerrero*, , United States Army, for heroism on 21 October 1981, while a member of Troop A, 1st Squadron, 17th Cavalry, 82d Airborne Division, Fort Bragg, North Carolina.

Staff Sergeant *David D. Jones*, , United States Army, for heroism on 23 February 1982, while a member of Company D, 3d Battalion, 3d Basic Training Brigade, United States Army Training Center Engineer and Fort Leonard Wood, Missouri. (This award supersedes the Meritorious Service Medal awarded to Staff Sergeant David D. Jones, for achievement on 23 February 1982, as announced in Permanent Orders 15-6, Headquarters, United States Army Training Center Engineer and Fort Leonard Wood, Fort Leonard Wood, Missouri, dated 15 March 1982.)

Sergeant *Boyd D. McClure*, , United States Army, for heroism on 25 February 1982, while a member of Headquarters and Headquarters Company, 1st Battalion, 73d Armor, National Training Center, Fort Irwin, California.

Specialist Four *Bryan T. Parker*, , United States Army, for heroism on 15 February 1982, while a member of the 55th Military Police Company, Camp Market, Korea.

Corporal *Steven L. Skyles*, , United States Army, for heroism on 13 June 1981, while a member of Headquarters and Headquarters Company, 1st Brigade, 3d Infantry Division, Germany.

Chief Warrant Officer (W-2) *Dennis J. Small*, , United States Army, for heroism on 10 February 1982, while a member of Company B, 101st Aviation Battalion, 101st Airborne Division, Fort Campbell,

Kentucky. (This award supersedes the Army Commendation Medal awarded to Chief Warrant Officer Dennis J. Small for heroism on 10 February 1982, as announced in Permanent Orders 55-3, Headquarters, 101st Airborne Division (Air Assault) and Fort Campbell, Fort Campbell, Kentucky, dated 24 February 1982.)

Sergeant First Class *Donald L. Williams*, , United States Army, for heroism on 9 March 1982, while a member of Company A, 4th Battalion, 1st Basic Training Brigade, Fort Jackson, South Carolina. (This award supersedes the Army Commendation Medal (Second Oak Leaf Cluster) awarded to Sergeant First Class Donald L. Williams for achievement on 9 March 1982, as announced in Permanent Orders 32-008, Headquarters, United States Army Training Center and Fort Jackson, South Carolina, dated 30 March 1982.)

Warrant Officer *Clifton P. Wolcott*, , United States Army, for heroism on 20 November 1981, while a member of Company A, 229th Attack Helicopter Battalion, Fort Campbell, Kentucky.

Staff Sergeant *Donald R. Youmans*, , United States Army, for heroism on 10 November 1981, while a member of Company B, 1st Battalion (Airborne), 504th Infantry, Fort Bragg, North Carolina.

V—MERITORIOUS SERVICE MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-15, AR 672-5-1, the Meritorious Service Medal for outstanding meritorious service is awarded to—

Captain *Jun Seung Ung*, , Republic of Korea Army, 15 July 1980 to 30 June 1982.

Captain *Peter Thomas Werner*, , Air Force of the Federal Republic of Germany, 14 September 1976 to 5 March 1982.

Major *Song Ki Yung*, , Republic of Korea Army, 6 October 1980 to 31 January 1982.

2. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal (First Oak Leaf Cluster) for meritorious service is awarded to—

Master Sergeant *Joerg Paul Witting*, , Army of the Federal Republic of Germany, 1 December 1978 to 31 March 1982.
