**ORGANIZATIONAL ACTIONS OF UNITS TO FORM  
THE 327TH INFANTRY REGIMENT UNDER  
THE US ARMY REGIMENTAL SYSTEM**

1. The 327th Infantry regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 21 January 1983. The 1st Bn, UIC: WACGAA and the 2d Bn, UIC: WACHAA of the 327th Infantry remains ASSIGNED to the 101st Airborne Division at Fort Campbell, KY.
2. INACTIVATE the 2d Bn, 502d Infantry, UIC: WACQAA under MTOE 7-55JFC21, FC3081 at Fort Campbell, KY, effective 21 January 1983. The 3d Bn, 327th Infantry, UIC: WG6VAA will be ACTIVATED and ASSIGNED to the 101st Airborne Division at Fort Campbell, KY under MTOE 7-55JFC21, FC3081 with the following strengths: STSTR: 34 OFF, 1 WO, 720 ENL, 755 AGG-AUSTR: 34 OFF, 1 WO, 666 ENL, 701 AGG, effective 21 January 1983.
3. INACTIVATE the 1st Bn, 60th Infantry, UIC: WASQAA under MTOE 7-175HFC86, FC1081 at Ft Richardson, AK, effective 6 January 1983. The 4th Bn, 327th Infantry, UIC: WH9QAA will be ACTIVATED and ASSIGNED to the 172d Infantry Brigade at Fort Richardson, AK under MTOE 7-175HFC86, FC1081 with the following strengths: STSTR: 35 OFF, 3 WO, 670 ENL, 708 AGG - AUSTR: 34 OFF, 3 WO, 606 ENL, 643 AGG effective 6 January 1983.
4. The 5th Bn, 327th Infantry, UIC: WH9RAA will be ACTIVATED and ASSIGNED to the 172d Infantry Brigade at Fort Richardson, AK under MTOE 7-175HFC86, FC1081 with the following strengths: STSTR: 35 OFF, 3 WO, 670 ENL, 708 AGG - AUSTR: 34 OFF, 3 WO, 606 ENL, 643 AGG, effective 6 January 1983.
5. INACTIVATE the 4th Bn, 9th Infantry, UIC: WASFAA under MTOE 7-175HFC86, FC1081 at Fort Wainwright, AK, effective 6 January 1983. The 6th Bn, 327th Infantry, UIC: WH9SAA will be ACTIVATED and ASSIGNED to the 172d Infantry Brigade at Fort Wainwright, AK under MTOE 7-175HFC86, FC1081 with the following strengths: STSTR: 35 OFF, 3 WO, 670 ENL, 708 AGG - AUSTR: 34 OFF, 3 WO, 606 ENL, 643 AGG, effective 6 January 1983.
