I—DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded posthumously to—

Sergeant First Class *Donald J. Hurt*, , United States Army, who distinguished himself by extraordinary heroism as Platoon Sergeant, Company G, 2d Battalion, 279th Infantry Regiment, while engaged in ground operations against an opposing armed force near Pokkea Ridge in the Yonchon-Chorwan Area, Korea, on 10 April 1952. While conducting a night patrol operation, Sergeant Hurt was leading his platoon through an abandoned village when they came under intense fire from enemy automatic weapons located on a small hill. After insuring that the platoon was in the proper defensive position, Sergeant Hurt fearlessly started up the hill with his carbine and several grenades to engage the enemy. At this time, he was knocked down and seriously wounded by a grenade blast. Completely disregarding his wounds, he managed to get back on his feet and throw several grenades to silence an enemy automatic weapon which was located on the forward slope of the hill. Additional enemy automatic weapons fire was now coming from the top of the hill and from the left right slopes. Continuing to ignore the pain caused by his wounds, Sergeant Hurt called for an artillery barrage to neutralize the enemy positions. Only after all enemy fire had ceased did he finally consent to be evacuated for medical treatment. The gallantry and aggressiveness displayed by Sergeant First Class Hurt directly resulted in routing the enemy and minimizing the casualties suffered by his comrades in this battle. His extraordinarily heroic actions, at the ultimate cost of his own life the next day, were in keeping with the most cherished traditions of military service and reflect the highest credit on him, the 45th Infantry Division, and the United States Army. (This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.)

II—LEGION OF MERIT. 1. 2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Lieutenant General *Hajime Araki*, , Japan Ground Self-Defense Force, 1 July 1980 to 30 June 1982.

Lieutenant General *Pierre Louis Brasart*, Army of the French Republic, 1 July 1978 to 16 December 1982.

Colonel *Francisco Veguillas Elices*, Army of Spain, August 1977 to August 1980.

Major General *Hans K. Nolzen*, , Army of the Federal Republic of Germany, 1 April 1979 to 28 September 1981.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Colonel *Johannes Mackowiak*, , Army of the Federal Republic of Germany, 1 October 1978 to 30 September 1982.

III—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to—

Staff Sergeant *Larry J. Ross*, , Arkansas Army National Guard, for heroism on 20 July 1981, while a member of Troop E, 151st Cavalry, Conway, Arkansas. (This award supersedes the Army Commendation Medal with "V" for Valor (Posthumously) as announced in Permanent Orders 25-1, The Military Department of Arkansas, Office of the Adjutant General, Camp Robinson, North Little Rock, Arkansas, dated 20 May 1982.)

IV—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to—

Sergeant *Gregory S. Bannister*, , United States Army, for heroism on 7 April 1982, while a member of the 988th Military Police Company, Fort Benning, Georgia.

First Sergeant *Jimmy L. Collins*, , United States Army, for heroism on 27 March 1982, while a member of Troop C, 1st Squadron, 2d

Armored Cavalry Regiment, Christensen Barracks, Federal Republic of Germany.

Staff Sergeant *Jeffrey S. Downey*, , United States Army, for heroism on 7 April 1982, while a member of Company D, 2d Battalion, 2d Infantry Training Brigade, Fort Benning, Georgia.

Sergeant First Class *John F. Flood*, , United States Army, for heroism on 15 June 1982, while a member of the United States Army Sacramento District Recruiting Command with duty at the Modesto Recruiting Station, California.

Sergeant First Class *Randy T. Hill*, , United States Army, for heroism on 15 June 1982, while a member of the United States Army Sacramento District Recruiting Command with duty at the Modesto Recruiting Station, California.

Specialist Four *John A. Lawrence*, , United States Army, for heroism on 29 August 1981, while a member of Company B, 76th Engineer Battalion, Fort Drum, New York.

Staff Sergeant *Charles R. Lucas*, , United States Army, for heroism on 27 February 1982, while a member of Company C, 4th Battalion, 63d Armor, Fort Riley, Kansas.

Sergeant First Class *Lemuel K. Outlaw*, , United States Army, for heroism on 7 April 1982, while a member of Company D, 2d Battalion, 2d Infantry Training Brigade, Fort Benning, Georgia.

V—BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" Device for heroism in connection with military operations against hostile forces is awarded to—

Sergeant *Hiram G. Velez*, , United States Army, for heroism on 17 November 1970, while serving as Assistant Patrol Leader with Company C, 4th Battalion (Airborne), 503d Infantry, 173d Airborne Brigade, Republic of Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

VI—MERITORIOUS SERVICE MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-15, AR 672-5-1, the Meritorious Service Medal for outstanding meritorious service is awarded to—
