**ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 68TH ARMY  
REGIMENT UNDER  
THE US ARMY REGIMENTAL SYSTEM**

1. So much of paragraph 1, Department of the Army General Orders 35, 20 July 1983 as reads: "The 68th Armor regiment is WITHDRAWN from the Combat Army Regimental System" is AMENDED to read: The 68th Armor regiment is WITHDRAWN from the Combat *Arms* Regimental System.

2. Department of the Army General Orders 35, 20 July 1983 is AMENDED to change the effective date in the following paragraph as indicated:

4. The 4th Bn, 68th Armor, UIC: WAZCAA will be REORGANIZED at zero strength, RELIEVED from ASSIGNMENT to the 82d Airborne Division at Fort Bragg, NC and REASSIGNED to the 4th Infantry Division at Fort Carson, CO under MTOE 17-235JFCO4, FC1084, effective 15 February 1984.

5. The 3d Bn, 73d Armor, UIC: WH23AA will be ACTIVATED and ASSIGNED to the 82d Airborne Division at Fort Bragg, NC under MTOE 17-215HFC82, FC1083 with the following strengths: STSTR: 32 OFF, 2 WO, 421 ENL, 455 AGG-AUSTR: 32 OFF, 2 WO, 414 ENL, 448 AGG, effective 15 February 1984.

7. INACTIVATE the 3d Bn, 10th Cavalry, UIC: WH55AA under MTOE 17-235JFCO4, FC1084 at Fort Hood, TX, effective 16 March 1984. The 4th Bn, 68th Armor, UIC: WAZCAA will be REORGANIZED and ASSIGNED to the 4th Infantry Division at Fort Carson, CO, under MTOE 17-235JFCO4, FC1084 with the following strengths: STSTR: 40 OFF, 2 WO, 523 ENL, 565 AGG-AUSTR: 40 OFF, 2 WO, 519 ENL, 561 AGG, effective 16 March 1984.
