## ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 3D FIELD ARTILLERY AND THE 41ST INFANTRY REGIMENTS UNDER THE US ARMY REGIMENTAL SYSTEM

1. Department of the Army General Orders 32, 15 July 1983 is AMENDED as follows:

Paragraph 2 is REVOKED and the following substituted thereafter:

- 2. The 3d Bn, 3d Field Artillery, UIC: WA2BAA will be REORGAN-IZED at zero strength, RELIEVED from ASSIGNMENT to the 194th Armored Brigade at Fort Knox, KY and REASSIGNED to the 2d Armored Division at Fort Hood, TX under MTOE 6-375HFC12, FC1083, effective 23 September 1983.
- 2. The existing paragraph 3 will be RENUMBERED as paragraph 4 and the existing paragraph 4 as paragraph 5.

- 3. INACTIVATE the 1st Bn, 78th Field Artillery, UIC: WAEAAA under MTOE 6-365HFC78, FC1084 at Fort Hood, TX, effective 1 October 1983. The 3d Bn, 3d Field Artillery, UIC: WA2BAA will be REORGAN-IZED under the 2d Armored Division at Fort Hood, TX under MTOE 6-365HFC78, FC1084 with the following strengths: STSTR: 44 OFF, 2 WO, 546 ENL, 592 AGG-AUSTR: 44 OFF, 2 WO, 528 ENL, 574 AGG, effective 1 October 1983.
- 4. Paragraph 6 is ADDED to read:
- 6. The 5th Bn, 41st Field Artillery, UIC: WH9YAA will be ACTI-VATED and ASSIGNED to the 194th Armored Brigade at Fort Knox, KY under MTOE 6-375HFC12, FC1083 with the following strengths: STSTR: 36 OFF, 5 WO, 572 ENL, 613 AGG-AUSTR: 36 OFF, 5 WO, 551 ENL, 592 AGG, effective 23 September 1983.
- 5. Paragraph 1 of Department of the Army General Orders 33, 15 July 1983 is REVOKED.
