I—LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Lieutenant General Sir *Phillip H. Bennett*, Royal Australian Army, February 1983 to October 1983.

General *Arthit Kamlang-ek*, Royal Thai Army, October 1982 to August 1983.

Brigadier General *Dario Paredes Rios*, Army of Panama, March 1982 to June 1983.

General *Johannes G. Roos*, Royal Netherlands Army, November 1980 to July 1983.

General *Ramon de Ascanio Y Togores*, Army of Spain, January 1982 to February 1983.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

General *Holmes Coitino*, Army of Uruguay, June 1979 to April 1983.

Brigadier General *Amos Gilboa*, Army of Israel, June 1981 to July 1982.

Major General *Jorge Martinez-Quiroga*, Army of Argentina, March 1979 to February 1981.

Major General *Mikhail Venetakis*, Army of Greece, August 1980 to September 1982.

General *Ferdinand M. Von Senger*, Army of the Federal Republic of Germany, October 1979.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to—

Colonel *Wolfgang Schade*, 300737-S-30749, Army of the Federal Republic of Germany, 1 January 1982 to 1 October 1983.

II—DISTINGUISHED FLYING CROSS. By direction of the President under the provisions of the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism in connection with military operations against hostile forces while participating in aerial flight is awarded posthumously to—

Captain *Keith J. Lucas*, , Military Intelligence, United States Army, for action on the island of Grenada on 25 October 1983, while a member of Company C, 158th Aviation Battalion, 101st Airborne Division (Air Assault), Fort Campbell, Kentucky.

III—DISTINGUISHED FLYING CROSS. By Direction of the President, under the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to—

Lieutenant Colonel (then First Lieutenant) *Carlos C. Langston, Jr.*, , Field Artillery, United States Army, for heroism on 6 October 1968 while assigned to 2d Battalion, 33rd Artillery (attached to the 1st Infantry Division), Republic of Vietnam.

IV—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to—

Sergeant First Class *Christopher W. Abel*, , United States Army, for heroism on 25 October 1983.

Master Sergeant *Francis M. Brownfield*, , United States Army, for heroism on 10 July 1983, while assigned to the United States Military Academy, West Point, New York.

Staff Sergeant *Lloyd D. Cannon*, , Pennsylvania Army National Guard, for heroism on 23 April 1983, while assigned to Company B, 2d Battalion, 111th Infantry, 712 Sproul Street, Chester, Pennsylvania. (This award supersedes the award of the Army Commendation Medal (First Oak Leaf Cluster) to Staff Sergeant Cannon for heroism during the period 1 December 1976 to 23 April 1983 as announced in Permanent Orders 5-1, Headquarters, 56th Brigade, 28th Infantry Division, Pennsylvania Army National Guard, Philadelphia, Pennsylvania, dated 3 June 1983).

Sergeant First Class *Paul M. Galan*, , United States Army Reserve, for heroism on 4 November 1982, while a member of Company B, 1st Battalion, 12th Special Forces Group (Airborne), Arlington Heights, Illinois. (This award supersedes the Army Commendation Medal awarded to Sergeant First Class Paul M. Galan for heroism on 1 March 1983 as announced in Permanent Orders 5-3, Headquarters, 86th United States Army Reserve Command, 7402 West Roosevelt Road, Forest Park, Illinois 60130, 1 May 1983).

Sergeant First Class *James M. Heustess*, , United States Army, for heroism on 11 June 1983, while assigned to Tulsa Area Army Recruiting, Oklahoma City District Recruiting Command, Tulsa, Oklahoma.

Sergeant First Class *Amos M. Howard*, , United States Army, for heroism on 25 October 1983.

Sergeant First Class *Jeffrey L. Huber*, , United States Army, for heroism on 25 October 1983.

Specialist Four *David J. Huberty*, , United States Army, for heroism on 8 May 1983, while assigned to Military Police Company, United States Army Field Artillery Center, Fort Sill, Oklahoma.

Sergeant First Class *Harvey G. Kerstetter, Jr.*, , United States Army, for heroism on 25 October 1983.

Major *Douglas R. Milne*, , Armor, United States Army, for heroism on 11 June 1983, while assigned to Headquarters, 3d Squadron, 2d Armored Cavalry Regiment, Pond Barracks, Amberg, Federal Republic of Germany. (This award supersedes the award of the Army Commendation Medal (First Oak Leaf Cluster) to Major Milne for heroism on 11 June 1983 as announced in Permanent Orders 78-4, Headquarters, 2d Armored Cavalry Regiment, APO New York 09093, dated 5 July 1983).

Chaplain (Captain) *William A. Robertson*, , United States Army, for heroism on 11 June 1983, while assigned to Headquarters, 3d Squadron, 2d Armored Cavalry Regiment, Pond Barracks, Amberg, Federal Republic of Germany. (This award supersedes the award of the Army Commendation Medal (First Oak Leaf Cluster) to Chaplain Robertson for heroism on 11 June 1983 as announced in Permanent Orders 78-5, Headquarters, 2d Armored Cavalry Regiment, APO New York 09093, dated 5 July 1983).

Captain *James M. Sikes*, , Armor, North Carolina Army National Guard, for heroism on 19 March 1983, while a member of Company D, 28th Aviation Battalion, North Carolina Army National Guard, Morrisville, North Carolina.
