**I—DISTINGUISHED SERVICE CROSS**—By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded to—

Master Sergeant *William A. Clemmons*, United States Army Retired (then Captain, United States Army), who distinguished himself by extraordinary heroism against an armed enemy in the vicinity of Xuan Loc, Vietnam, on 14 June 1971, while serving as Commander of Company D, 2d Battalion (Airmobile), 5th Cavalry. Company D, while on a reconnaissance mission east of Xuan Loc, encountered an undetermined superior size force which opened fire with 40mm rockets, automatic weapons fire, claymores, and 60mm mortars. During the initial contact the front platoon suffered immediate heavy casualties. Sergeant Clemmons maneuvered the two uncommitted platoons to provide supporting fire on both flanks where the casualties were located, while directing gunship and artillery fire to suppress the enemy's fire superiority. While the flank platoons provided supporting fire, Sergeant Clemmons advanced to the enemy's killing zone to bring back his wounded men. He pulled one man back and carried him to a safe location. Upon his return, he was wounded in the chest by AK-47 fire. Bleeding severely and crawling, he reentered the killing zone and brought back two other wounded men. His men, inspired by his action, increased the tempo of aggressiveness and their fire while maneuvering and closing in on the enemy. Sergeant Clemmons, in pain and bleeding profusely, crawled a third time into the killing zone and retrieved a fourth wounded man. Rejoining the closing and flanking platoons, Sergeant Clemmons directed air and artillery fire on the bunker complex occupied by the larger enemy force and continued to direct the platoons closing in on the enemy, forcing them to withdraw and abandon their fortified bunkers which saved the lives of several of his seriously wounded men still caught in the enemy's killing zone. Master Sergeant Clemmons' extraordinary heroism, exemplary leadership, and interest in the welfare of his men were in keeping with the highest traditions of military service and reflect great credit on him, his unit, and the United States Army. (This award is authorized under the provisions of para 1-30, AR 672-5-1.)

**II—SILVER STAR**—By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Sergeant First Class *William D. Austin*, (then Specialist Four), United States Army, for heroism on 19 September 1967, while a member of Company A, 2d Battalion (Airborne), 502d Infantry, 101st Airborne Division, Viet-

nam. This award is authorized under the provisions of paragraph 1-30, AR 672-5-1.

**II—LEGION OF MERIT—1.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

**VII—VALOROUS UNIT AWARD**—By direction of the Secretary of the Army, under the provisions of paragraphs 9-2 and 9-19, AR 672-5-1, the Valorous Unit Award is awarded to the following named units of the United States Army for extraordinary heroism while engaged in military operations during the period indicated:

#### THE 1ST AND 2D BATTALIONS (RANGER), 75th INFANTRY UNITED STATES ARMY

Citation reads as follows:

The 1st and 2d Battalions (Ranger), 75th Infantry, distinguished themselves by extraordinary heroism while engaged in military operations on the island of Grenada during the period 25 October 1983 to 28 October 1983. While conducting an airborne assault against well emplaced and positioned Cuban and Grenadian forces, soldiers of the two Ranger Battalions came under intense enemy antiaircraft fire. During the assault, elements of each unit began clearing the airfield of obstacles prepositioned to prevent friendly aircraft from landing. While conducting clearing operations, the Ranger forces came under intense enemy fire from the high ground surrounding the airfield. Organizing into platoon and smaller sized elements, vicious and aggressive attacks were launched on the entrenched enemy forces. In a matter of hours, the Rangers had cleared the airfield of all obstacles and the enemy from commanding positions surrounding the airfield. The Rangers then proceeded to rescue several hundred trapped American citizens from behind enemy lines. One of several rescues was so successful that not one casualty was

sustained by friendly forces or civilians. Within 3 days of combat, the Rangers captured more than 400 enemy personnel. Throughout the operation, the men of the 1st and 2d Battalions (Ranger), 75th Infantry, displayed exemplary esprit and an unwavering commitment to mission accomplishment that inspired them to uncommon feats of gallantry and sacrifice. Their demonstrated determination, devotion to duty, and indomitable courage were in keeping with the highest traditions of military service and reflect the highest credit on their units and the Armed Forces of the United States of America.

**VIII—JOINT MERITORIOUS UNIT AWARD**—By direction of the Secretary of Defense, under the provisions of Department of Defense Directive 1348.27, dated July 22, 1982, award of the Joint Meritorious Unit Award to the following units of the Armed Forces of the United States for exceptionally meritorious service in pursuit of joint military missions of great significance is confirmed in accordance with paragraph 9-9, AR 672-5-1.
