**I—LEGION OF MERIT**—1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:
