**I—SILVER STAR.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Master Sergeant *John Al Ross*, , United States Army, Retired (then serving as Sergeant First Class, United States Army), for gallantry in action on 28 May 1951 near Inje, North Korea, while a member of Company I, 3d Battalion, 187th Airborne Regimental Combat Team. (This award is authorized under the provisions of AR 672-5-1, paragraphs 1-13d and 2-10.)

**II—LEGION OF MERIT.** 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942 and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

General *Khalid Mahmud Arif*, Pakistani Army, March 1984 to July 1985.

Major General *Jose E. Cruz-Brea*, Army of the Dominican Republic, August 1984 to June 1985.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding services is awarded to:

Colonel *Hans-Carl von Winterfeld*, Army of the Federal Republic of Germany, 1 July 1978 to 29 September 1985.

Colonel *Andreas F. Wittenberg*, Army of the Federal Republic of Germany, 30 September 1982 to 9 September 1985.

**III—SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, the Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private First Class *Guy E. Bartolomei*, , United States Army, for heroism on 9 November 1984, while a member of Headquarters and Headquarters Company, 4th Psychological Operations Group, Fort Bragg, North Carolina.

Specialist Four *David J. Beach*, , United States Army, for heroism on 11 February 1985, while a member of Battery A, 2d Battalion, 10th Field Artillery, Federal Republic of Germany.

Staff Sergeant *Howard D. Beaton*, , United States Army, for heroism on 9 December 1984, while a member of United States Army Cold Regions Test Center, Fort Greely, Alaska. (This award supersedes the Army Commendation Medal (First Oak Leaf Cluster) awarded to Staff Sergeant Howard D. Beaton, 115-42-4855, for heroism on 9 December 1984, as announced in Permanent Orders 24-203, Headquarters, 172d Infantry Brigade (Alaska) (Fort Greely), APO Seattle 98733, dated 8 March 1985).

Sergeant *Cory A. Chapman*, , United States Army, for heroism on 21 April 1985, while a member of Company B, 101st Aviation Battalion (Assault Helicopter), 101st Airborne Division (Air Assault), Fort Campbell, Kentucky.

Sergeant *David V. Jones*, , United States Army, for heroism on 7 November 1984, while a member of the 1st Battalion, 15th Infantry Medical Platoon, Federal Republic of Germany.

Specialist Four *Robert P. Lindsay*, , United States Army, for heroism on 12 January 1985, while a member of Headquarters and Headquarters Company, 25th Infantry Division, Schofield Barracks, Hawaii.

Sergeant *Jessie G. Schatz*, , United States Army, for heroism on 24 March 1985, while a member of the United States Military Liaison Mission, United States Army, Europe.

Warrant Officer *Kevin A. Wellington*, , United States Army, for heroism on 7 August 1984, while a member of Company B, 8th Combat Aviation Battalion, 8th Infantry Division (Mechanized), Federal Republic of Germany.

**IV—MERITORIOUS SERVICE MEDAL.** By direction of the Secretary of the Army, under the provisions of AR 672-5-1, paragraph 2-17, the Meritorious Service Medal for outstanding meritorious service is awarded to:
