I—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 62D AIR DEFENSE ARTILLERY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).

1. The 62d Air Defense Artillery regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 August 1986. The 1st Bn, UIC: WAXCAA remains ASSIGNED to the 25th Infantry Division at Schofield Barracks, Hawaii.

2. The 1st Bn, 51st Air Defense Artillery, UIC: WD2TAA will be INACTIVATED under MTOE 44-115JFC07, FC1086 at Ford Ord, CA, effective 16 August 1986. The 2d Bn, 62d Air Defense Artillery, UIC: WD2VAA will be ACTIVATED and ASSIGNED to the 7th Infantry Division at Fort Ord, CA under MTOE 44-115JFC07, FC1086 with the following strengths: STSTR: 28 OFF, 2 WO, 292 ENL, 322 AGG-AUSTR: 28 OFF, 2 WO, 292 ENL, 322 AGG, effective 16 August 1986.

3. The 4th Bn, 1st Air Defense Artillery, UIC: WAWSAA will be INACTIVATED under MTOE 44-325HFC07, FC1084 at Fort Bliss, TX, effective 16 August 1986. The 5th Bn, 62d Air Defense Artillery, UIC: WDRNAA will be ACTIVATED at Fort Bliss, TX under MTOE 44-325HFC07, FC1084 with the following strengths: STSTR: 35 OFF, 7 WO, 551 ENL, 593 AGG-AUSTR: 35 OFF, 7 WO, 551 ENL, 593 AGG, effective 16 August 1986.

II—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 77TH FIELD ARTILLERY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).

1. The 77th Field Artillery regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 17 August 1986. The 4th Bn, 77th Field Artillery remains ASSIGNED to the V Corps in Germany.

2. The 5th Bn, 41st Field Artillery, UIC: WH9YAA will be INACTIVATED under MTOE 6-365HFC41, FC1086 at Fort Knox, KY, effective 17 August 1986. The 1st Bn, 77th Field Artillery, UIC: WAG6AA will be ACTIVATED and ASSIGNED to the 194th Armored Brigade at Fort Knox, KY under MTOE 6-365HFC41, FC1086 with the following strengths: STSTR: 44 OFF, 5 WO, 564 ENL, 613 AGG-AUSTR: 44 OFF, 5 WO, 564 ENL, 595 AGG, effective 17 August 1986.

3. The 2d Bn, 77th Field Artillery will ACTIVATE in FY 88.

III—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 20TH INFANTRY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).

1. The 20th Infantry regiment is WITHDRAWN from the Combat

2. INACTIVATE the 1st Bn, 17th Infantry, UIC: WAK8AA under MTOE 7-245J220, P80186 in Korea, effective 16 August 1986. The 5th Bn, 20th Infantry, UIC: WA4FAA will be ACTIVATED and ASSIGNED to the 2d Infantry Division in Korea under MTOE 7-245J220, P80186 with the following strengths: STSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG-AUSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG, effective 16 August 1986.

IV—THE U.S. ARMY REGIMENTAL SYSTEM (USARS). The 35th Field Artillery regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 18 August 1986.
