**I. ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 22D INFANTRY REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS).** Section III, paragraph 4, Department of the Army General Orders No. 27, 30 June 1986 pertaining to the 4th Bn, 22d Infantry, UIC: WERCAA as reads: "effective 17 November 1986" is AMENDED to read: *effective 16 November 1986.*

**II. ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 51ST INFANTRY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).** 1. The 51st Infantry regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 September 1986.

2. Company E, 51st Infantry, UIC: WG4YAA will be ACTIVATED in Germany under MTOE 7-157HE101, E10186 with the following strengths: STSTR: 7 OFF, 182 ENL, 189 AGG-AUSTR: 6 OFF, 138 ENL, 144 AGG, effective 16 September 1986.

3. Company F, 51st Infantry, UIC: WG1QAA will be ACTIVATED in Germany under MTOE 7-157HE101, E10186 with the following strengths: STSTR: 7 OFF, 182 ENL, 189 AGG-AUSTR: 6 OFF, 138 ENL, 144 AGG, effective 16 September 1986.

**III. THE U.S. ARMY REGIMENTAL SYSTEM (USARS).** The following regiments will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective on dates shown:
