**ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 82D AVIATION  
REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS)**

1. The 82d Aviation Bn will be REORGANIZED and REDESIGNATED as the 82d Aviation regiment under the US Army Regimental System effective 15 January 1987.
2. The 82d Aviation Bn, UIC: WAA8AA, (less Cos A, B, C and D) will be INACTIVATED under MTOE 57-55HFC82, FC1086 at Fort Bragg, NC, effective 15 January 1987. Co A, 82d Aviation Bn, UIC: WAA8AO will be REORGANIZED and REDESIGNATED as HHC, 1st Bn, 82d Aviation, UIC: WGDQAA under MTOE 1-395LFC82, FC1187 with the following strengths: STSTR: 24 OFF, 51 WO, 170 ENL, 245 AGG-AUSTR: 24 OFF, 51 WO, 170 ENL, 245 AGG and remains ASSIGNED to the 82d Airborne Division at Fort Bragg, NC, effective 15 January 1987. Companies A, B and C, 1st Bn, 82d Aviation will be CONSTITUTED and ACTIVATED at Fort Bragg, NC, effective 15 January 1987.
3. Co B, 82d Aviation Bn, UIC: WAA8B0 will be REORGANIZED and REDESIGNATED as Co B, 82d Aviation, UIC: WCO8AA under MTOE 1-147LFC82, FC1087 with the following strengths: STSTR: 8 OFF, 28 WO, 69 ENL, 105 AGG-AUSTR: 8 OFF, 28 WO, 69 ENL, 105 AGG and remains ASSIGNED to the 82d Airborne Division at Fort Bragg, NC, effective 15 January 1987.
4. Co C, 82d Aviation Bn, UIC: WAA8CO will be REORGANIZED and REDESIGNATED as Co C, 82d Aviation, UIC: WDDRAA under MTOE 1-147LFC82, FC1087 with the following strengths: STSTR: 8 OFF, 28 WO, 69 ENL, 105 AGG-AUSTR: 8 OFF, 28 WO, 69 ENL, 105 AGG and remains ASSIGNED to the 82d Airborne Division at Fort Bragg, NC, effective 15 January 1987.
5. Co D, 82d Aviation Bn, UIC: WAA8DO will be REORGANIZED and REDESIGNATED as Co D, 82d Aviation, UIC: WEQZAA under MTOE 1-412LFC82, FC1187 with the following strengths: STSTR: 8 OFF, 12 WO, 194 ENL, 214 AGG-AUSTR: 8 OFF, 12 WO, 194 ENL, 214 AGG and remains ASSIGNED to the 82nd Airborne Division at Fort Bragg, NC, effective 15 January 1987.
