# **I—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 10TH FIELD ARTILLERY REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS).**

1. The 10th Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 March 1987.

2. The 1st Bn, 27th Field Artillery, UIC: WD3EAA will be INACTIVATED at Fort Carson, CO under MTOE 6-398JFC04, FC1087, effective 16 March 1987. Btry C, 10th Field Artillery, UIC: WD3EAA will be ACTIVATED and ASSIGNED to the 4th Infantry Division at Fort Carson, CO under MTOE 6-398JFC04, FC1087 with the following strengths: 6 OFF, 125 ENL, 131 AGG-AUSTR: 6 OFF, 125 ENL, 131 AGG effective 16 March 1987.

# **II—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 21ST FIELD ARTILLERY REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS).**

1. The 21st Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 March 1987. Btry A, 21st Field Artillery, UIC: WAG4AA remains ASSIGNED to the 1st Cavalry Division at Fort Hood, TX.

2. HHB, 3d Bn, 21st Field Artillery, UIC: WA2UAA will be REORGANIZED and REDESIGNATED as Btry C, 21st Field Artillery, UIC: WAGUAA under MTOE 6-398JFC05, FC1087 with the following strengths: STSTR: 6 OFF, 126 ENL, 131 AGG-AUSTR: 6 OFF, 125 ENL, 131 AGG and remains ASSIGNED to the 5th Infantry Division at Fort Polk, LA, effective 16 March 1987.

3. The remaining organic batteries of the 3d Bn, 21st Field Artillery will be INACTIVATED effective 16 March 1987.
