12TH FIELD ARTILLERY REGIMENT UNDER THE U.S.  
ARMY REGIMENTAL SYSTEM (USARS)**

1. The 12th Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 July 1987. The 1st Bn, UIC: WAJLAA remains at Fort Sill, OK.
2. The 2d Bn, 377th Field Artillery, UIC: WABQAA will be INACTIVATED in Germany under MTOE 6-595HE101, E10386, effective 16 July 1987. The 2d Bn, 12th Field Artillery, UIC: WABQAA will be ACTIVATED in Germany under MTOE 6-595HE101, E10386 with the following strengths: STSTR: 40 OFF, 30 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 ENL, 434 AGG, effective 16 July 1987.
3. The 1st Bn, 80th Field Artillery, UIC: WDPLAA will be INACTIVATED in Germany under MTOE 6-595HE101, E10386, effective 16 July 1987. The 3d Bn, 12th Field Artillery, UIC: WDPLAA will be ACTIVATED in Germany under MTOE 6-595HE101, E10386 with the following strengths: STSTR: 40 OFF, 3 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 ENL, 434 AGG, effective 16 July 1987.
4. The 4th Bn, 42d Field Artillery, UIC: WH14AA will be INACTIVATED in Germany under MTOE 6-595HE101, E10386, effective 16 July 1987. The 4th Bn, 12th Field Artillery, UIC: WH14AA will be ACTIVATED in Germany under MTOE 6-595HE101, E10386 with the following strengths: STSTR: 40 OFF, 3 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 EN, 434 AGG, effective 16 July 1987.
