32D FIELD ARTILLERY REGIMENT UNDER THE
U.S. ARMY REGIMENTAL SYSTEM (USARS)**

1. The 32d Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 August 1987. The 1st Bn, UIC: WA2WAA remains in Germany.
2. The 3d Bn, 79th Field Artillery, UIC: WA2ZAA will be INACTIVATED in Germany under MTOE 6-595HE101, E10386, effective 16 August 1987. The 2d Bn, 32d Field Artillery, UIC: WA2ZAA will be ACTIVATED in Germany under MTOE 6-595HE101, E10386 with the following strengths: STSTR: 40 OFF, 3 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 ENL, 434 AGG, effective 16 August 1987.
3. The 1st Bn, 333d Field Artillery, UIC: WCZVAA will be INACTIVATED in Germany under MTOE 6-595HE101, E10386, effective 16 August 1987. The 3d Bn, 32d Field Artillery, UIC: WCZVAA will be ACTIVATED in Germany under MTOE 6-595HE101, E10386 with the following strengths: STSTR: 40 OFF, 3 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 ENL, 434 AGG, effective 16 August 1987.
4. The 6th Bn, 33d Field Artillery, UIC: WE8RAA will be INACTIVATED at Fort Sill, OK under MTOE 6-595HFC02, FC1087, effective 16 August 1987. The 6th Bn, 32d Field Artillery, UIC: WE8RAA will be ACTIVATED at Fort Sill, OK under MTOE 6-595HFC02, FC1087 with the following strengths: STSTR: 40 OFF, 3 WO, 422 ENL, 465 AGG-AUSTR: 39 OFF, 3 WO, 392 ENL, 434 AGG, effective 16 August 1987.
