ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 58TH AVIATION REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS)

Department of the Army General Orders No. 39 dated 10 July 1987 is AMENDED as follows:

- 1. Paragraph 1 is changed to read as follows:
- "1. The 58th Aviation Bn will be REDESIGNATED and ACTIVATED as the 58th Aviation regiment under the U.S. Army Regimental System, effective 16 July 1987."
- 2. Paragraph 2 is changed to read as follows:
- "2. Hq Co, 58th Aviation Bn, UIC: WGGLTO will be REDESIGNATED and ACTIVATED as HHC, 1st Bn, 58th Aviation, UIC: WHPCAA under MTOE 95–226JFC04, FC1087 with the following strengths: STSTR: 11 OFF, 10 WO, 56 ENL, 77 AGG—AUSTR: 11 OFF, 7 WO, 49 ENL, 67 AGG and remains at Fort Bragg, NC, effective 16 July 1987. Organic elements of the 1st Bn, 58th Aviation will be CONSTITUTED and ACTIVATED at Fort Bragg, NC, effective 16 July 1987."
- 3. Paragraph 3 is changed to read as follows:
- "3. Co A, 58th Aviation Bn, UIC: WGGLAO will be REDESIGNATED and ACTIVATED as HHC, 2d Bn, 58th Aviation, UIC: WHPFAA under MTOE 95–226JFC05, FC1087 with the following strengths: STSTR: 11 OFF, 9 WO, 56 ENL, 76 AGG—AUSTR: 11 OFF, 7 WO, 44 ENL, 62 AGG and remains at Fort Hood, TX, effective 16 July 1987. Organic elements of the 2d Bn, 58th Aviation will be CONSTITUTED and ACTIVATED at Fort Hood, TX, effective 16 July 1987."
- **4.** Paragraph 4 is changed to read as follows:
- "4. Co B, 58th Aviation Bn, UIC: WGGLBO will be REDESIGNATED and ACTIVATED as HHC, 3d Bn, 58th Aviation, UIC: WHN8AA under MTOE 95–226JE106, E10187 with the following strengths: STSTR: 11 OFF, 10 WO, 57 ENL, 78 AGG-AUSTR: 10 OFF, 7 WO, 54 ENL, 71 AGG and remains in Germany, effective 16 July 1987. Organic elements of the 3d Bn, 58th Aviation will be CONSTITUTED and ACTIVATED in Germany, effective 16 July 1987."
- 5. Paragraph 5 is changed to read as follows:
- "5. Co C, 58th Aviation Bn, UIC: WGGLCO will be REDESIGNATED and ACTIVATED as HHC, 4th Bn, 58th Aviation, UIC: WHN5AA under MTOE 95–226JP801, P80187 with the following strengths: STSTR: 11 OFF, 10 WO, 55 ENL, 76 AGG-AUSTR: 8 OFF, 9 WO, 51 ENL, 68 AGG and remains in Korea, effective 16 July 1987. Organic elements of the 4th Bn, 58th Aviation will be CONSTITUTED and ACTIVATED in Korea, effective 16 July 1987."

"6. Co E, 58th Aviation, UIC: WHN9AA will be ACTIVATED in Germany under MTOE 95–223JE101, E10188 with the following strengths: STSTR: 3 OFF, 2 WO, 90 ENL, 95 AGG-AUSTR: 3 OFF, 2 WO, 85 ENL, 90 AGG, effective 16 July 1987."
