## ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 24TH AVIATION REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS)

Co A, 24th Avn Bn, UIC: WAQLAO will be REORGANIZED and REDESIGNATED as HHC, 1st Bn, 24th Aviation, UIC: WAQLAA under MTOE 1–385LFC24, FC2088 with the following strengths: STSTR: 22 OFF, 50 WO, 207 ENL, 279 AGG-AUSTR: 22 OFF, 50 WO, 207 ENL, 279 AGG and remains ASSIGNED to the 24th Infantry Division at Fort Stewart, GA, effective 16 October 1987. Organic elements of the 1st Bn, 24th Aviation will be CONSTITUTED and ACTIVATED at Fort Stewart, GA, effective 16 October 1987.
