**ORGANIZATIONAL ACTIONS OF UNITS TO FORM  
 THE 5TH AVIATION REGIMENT UNDER  
 THE U.S. ARMY REGIMENTAL SYSTEM (USARS)**

1. The 5th Aviation Bn will be REORGANIZED and REDESIGNATED as the 5th Aviation regiment under the U.S. Army Regimental System, effective 16 November 1987.
2. The 5th Aviation Bn, UIC: WH6HAA (less Hqs Co and Cos A, D and E) will be INACTIVATED under MTOE 1-385JFC05, FC1086 at Fort Polk, LA, effective 16 November 1987. Co D, 5th Aviation Bn, UIC: WH6HDO will be REORGANIZED and REDESIGNATED as Co D, 5th Aviation, UIC: WAX8AA under MTOE 1-287JFC05, FC1086 with the following strengths: STSTR: 7 OFF, 22 WO, 97 ENL, 126 AGG-AUSTR: 7 OFF, 22 WO, 97 ENL, 126 AGG and remains ASSIGNED to the 5th Infantry Division at Fort Polk, LA, effective 16 November 1987.
3. Co E, 5th Aviation Bn, UIC: WH6HEO will be REORGANIZED and REDESIGNATED as Co E, 5th Aviation, UIC: WAR5AA under MTOE 1-257JFC05, FC1087 with the following strengths: STSTR: 7 OFF, 45 WO, 116 ENL, 168 AGG-AUSTR: 7 OFF, 45 WO, 116 ENL, 168 AGG and remains ASSIGNED to the 5th Infantry Division at Fort Polk, LA, effective 16 November 1987.
4. Hqs Co, 5th Aviation Bn, UIC: WH6HTO will be REORGANIZED and REDESIGNATED as Co F, 5th Aviation, UIC: WE4DAA under MTOE 55-427JFC05, FC1086 with the following strengths: STSTR: 8 OFF, 10 WO, 198 ENL, 216 AGG-AUSTR: 8 OFF, 10 WO, 198 ENL, 216 AGG and remains ASSIGNED to the 5th Infantry Division at Fort Polk, LA, effective 16 November 1987.
5. Co A, 5th Aviation Bn, UIC: WH6HAO will be REORGANIZED and REDESIGNATED as HHC, 1st Bn, 5th Aviation, UIC: WH6HAA under MTOE 1-385LFC05, FC2088 with the following strengths: STSTR: 22 OFF, 50 WO, 207 ENL, 279 AGG-AUSTR: 22 OFF, 50 WO, 207 ENL, 279 AGG and remains ASSIGNED to the 5th Infantry Division at Fort Polk, LA, effective 16 November 1987. Organic elements of the 1st Bn, 5th Aviation will be CONSTITUTED and ACTIVATED at Fort Polk, LA effective 16 November 1987.
