**ORGANIZATIONAL ACTIONS OF UNITS TO FORM  
 THE 7TH INFANTRY REGIMENT UNDER  
 THE U.S. ARMY REGIMENTAL SYSTEM (USARS)**

1. The 7th Infantry regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 December 1987. The 1st Bn, 7th Infantry UIC: WAMWAA remains ASSIGNED to the 3d Infantry Division in Germany.
2. The 2d Bn, 21st Infantry, UIC: WAQGAA will be INACTIVATED at Fort Stewart, GA under MTOE 7-245JFC24, FC1087 effective 16 December 1987. The 2d Bn, 7th Infantry, UIC: WAQGAA will be ACTIVATED and ASSIGNED to the 24th Infantry Division at Fort Stewart, GA under MTOE 7-245JFC24, FC1087 with the following strengths: STSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG-AUSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG, effective 16 December 1987.
3. The 2d Bn, 34th Infantry, UIC: WAQYAA will be INACTIVATED at Fort Stewart, GA under MTOE 7-245JFC24, FC1087 effective 16 December 1987. The 3d Bn, 7th Infantry, UIC: WAQYAA will be ACTIVATED and ASSIGNED to the 24th Infantry Division at Fort Stewart, GA under MTOE 7-245JFC24, FC1087 with the following strengths: STSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG-AUSTR: 45 OFF, 2 WO, 779 ENL, 826 AGG, effective 16 December 1987.
4. The 1st Bn, 4th Infantry UIC: WAMUAA will be INACTIVATED in Germany under MTOE 7-245JE102, E10187 effective 16 December 1987. The 4th Bn, 7th Infantry, UIC: WAMUAA will be ACTIVATED and ASSIGNED to the 3d Infantry Division in Germany under MTOE 7-245JE102, E10187 with the following strengths: STSTR: 45 OFF, 2 WO, 798 ENL, 845 AGG-AUSTR: 45 OFF, 2 WO, 798 ENL, 845 AGG effective 16 December 1987.
