**ORGANIZATIONAL ACTIONS OF UNITS TO FORM
THE 9TH AVIATION REGIMENT UNDER
THE U.S. ARMY REGIMENTAL SYSTEM (USARS)**

1. The 9th Aviation Bn will be REORGANIZED and REDESIGNATED as the 9th Aviation regiment under the U.S. Army Regimental System, effective 16 December 1987.
2. The 9th Aviation Bn, UIC: WDFWAA (less Cos A, B and C) will be INACTIVATED at Fort Lewis, WA under MTOE 1-285DFC09, FC1186 effective 16 December 1987. Co A, 9th Aviation Bn, UIC: WDFWAO will be REORGANIZED and REDESIGNATED as HHC, 1st Bn, 9th Aviation, UIC: WDU2AA under MTOE 17-385DFC09, FC2086 with the following strengths: STSTR: 24 OFF, 54 WO, 215 ENL, 293 AGG-AUSTR: 24 OFF, 54 WO, 215 ENL, 293 AGG and remains ASSIGNED to the 9th Infantry Division at Fort Lewis, WA effective 16 December 1987. Organic elements of the 1st Bn, 9th Aviation will be CONSTITUTED and ACTIVATED at Fort Lewis, WA effective 16 December 1987.
3. Co B, 9th Aviation Bn, UIC: WDFWBO will be REORGANIZED and REDESIGNATED as HHC, 2d Bn, 9th Aviation, UIC: WDFWAA under MTOE 1-285DFC09, FC1186 with the following strengths: STSTR: 38 OFF, 89 WO, 397 ENL, 524 AGG-AUSTR: 39 OFF, 89 WO, 395 ENL, 523 AGG and remains ASSIGNED to the 9th Infantry Division at Fort Lewis, WA effective 16 December 1987. Organic elements of the 2d Bn, 9th Aviation will be CONSTITUTED and ACTIVATED at Fort Lewis WA effective 16 December 1987.
4. Co C, 9th Aviation Bn, UIC: WDFWCO will be REORGANIZED and REDESIGNATED as HHC, 3d Bn, 9th Aviation, UIC: WHPSAA under MTOE 63-25DFC09, FC1086 with the following strengths: STSTR: 21 OFF, 14 WO, 376 ENL, 411 AGG-AUSTR: 21 OFF, 13 WO, 352 ENL, 386 AGG and remains ASSIGNED to the 9th Infantry Division at Fort Lewis, WA effective 16 December 1987. Organic elements of the 3d Bn, 9th Aviation will be CONSTITUTED and ACTIVATED at Fort Lewis, WA effective 16 December 1987.
