**ORGANIZATIONAL ACTIONS OF UNITS TO FORM
 THE 123D AVIATION REGIMENT UNDER
 THE U.S. ARMY REGIMENTAL SYSTEM (USARS)**

Organic elements of the 1st Bn, 123d Aviation will be CONSTITUTED and ACTIVATED at Fort Ord, CA, effective 16 September 1987.
6. Co F, 123d Aviation, UIC: WDUTAA will be ACTIVATED and ASSIGNED to the 6th Infantry Division at Fort Wainwright, AK, under MTOE 1-103LFC16, FC1388 with the following strengths: STSTR: 6 OFF, 30 WO, 79 ENL, 115 AGG-AUSTR: 6 OFF, 30 WO, 79 ENL, 115 AGG, effective 16 September 1987.
