- 4. The 2d Bn, 60th Air Defense Artillery, UIC: WGMRAA will be INACTIVATED in Germany under MTOE 44–325HE101, E10188, effective 16 March 1988. The 3d Bn, 44th Air Defense Artillery, UIC: WGMRAA will be ACTIVATED in Germany under MTOE 44–325HE101, E10188 with the following strengths: STSTR: 34 OFF, 6 WO, 560 ENL, 600 AGG-AUSTR: 34 OFF, 2 WO, 462 ENL, 498 AGG, effective 16 March 1988.
- 5. The 6th Bn, 56th Air Defense Artillery, UIC: WAV1AA will be INACTIVATED in Germany under MTOE 44–725HE101, E10188, effective 16 March 1988. The 5th Bn, 44th Air Defense Artillery, UIC: WAV1AA will be ACTIVATED in Germany under MTOE 44–725HE101, E10188 with the following strengths: STSTR: 34 OFF, 6 WO, 560 ENL, 600 AGG-AUSTR: 32 OFF, 2 WO, 510 ENL, 546 AGG, effective 16 March 1988.
