## I-ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 7TH CAVALRY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).

- 1. Effective 16 February 1989, the 7th Cavalry regiment will be WITH-DRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System. The 1st Sqdn, UIC: WAGTAA remains ASSIGNED to the 1st Cavalry Division at Fort Hood, TX, the 2nd Sqdn, UIC: WAKEAA remains ASSIGNED to the 4th Infantry Division at Fort Carson, CO and the 3d Sqdn, UIC: WAPJAA remains ASSIGNED to the 8th Infantry Division in Germany.
- 2. The 3d Sqdn, 12th Cavalry, UIC: Effective 16 February 1989, WAETAA will be INACTIVATED in Germany under MTOE 17–385LE102, E10189. The 4th Sqdn, 7th Cavalry, UIC: WAETAA will be ACTIVATED and ASSIGNED to the 3d Armored Division in Germany under MTOE 17–385LE102, E10189 with the following strengths: STSTR: 36 OFF, 26 WO, 486 ENL, 548 AGG-AUSTR: 36 OFF, 26 WO, 486 ENL, 548 AGG, effective 16 February 1989.

## II-ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 77TH ARMOR REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS).

The 3d Bn, 77th Armor, UIC: WFMAAA will be ACTIVATED and ASSIGNED to the 8th Infantry Division in Germany under MTOE 17-235JE103, E10388 with the following strengths: STSTR: 40 OFF, 2 WO, 507 ENL, 549 AGG-AUSTR: 34 OFF, 2 WO, 507 ENL, 543 AGG, effective 16 February 1989.
