**I—UNITED STATES ARMY FORCE DEVELOPMENT SUPPORT AGENCY (SFW4PCAA).** This confirms that effective 1 June 1989, the United States Army Force Development Support Agency, a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans was redesignated by the Army Vice Chief of Staff as the United States Army Force Integration Support Agency, a Field Operating Agency remaining under the jurisdiction of the Deputy Chief of Staff for Operations and Plans. Unit Identification Code (SFW4PCAA) continues in effect.

**II—UNITED STATES ARMY MANPOWER REQUIREMENTS AND DOCUMENTATION AGENCY (SFW4LJAA).** This confirms that effective 1 June 1989, the personnel and functions of the United States Army Manpower Requirements and Documentation Agency, a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Personnel, were transferred by the Army Vice Chief of Staff to the United States Army Force Integration Support Agency, a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans. Unit Identification Code (SFW4LJAA) was discontinued effective 1 June 1989.


**III—UNITED STATES ARMY EQUIPMENT AUTHORIZATION REVIEW AGENCY (SFWOJDAA).** This confirms that effective 1 June 1989, the personnel and functions of the United States Army Equipment Authorization Review Agency, a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Logistics, were transferred by the Army Vice Chief of Staff to the United States Army Force Integration Support Agency, a Field Operating Agency under the jurisdiction of the Deputy Chief of Staff for Operations and Plans. Unit Identification Code (SFWOJDAA) was discontinued effective 1 June 1989.
