Lieutenant Colonel *Eckehardt Westphal*, Army of the Federal Republic of Germany, 28 August 1986 to 8 December 1989.

Lieutenant Colonel *Joshu Yamaguchi*, Japan Ground Self-Defense Force, 1 August 1987 to 15 March 1990.

2. By direction of the Secretary of the Army, under AR 672-5-1, paragraph 2-20, the Army Commendation Medal for meritorious achievement is awarded to the following:

Captain *Emile Bazèrque*, French Army, 26 February 1990 to 2 March 1990.

First Lieutenant *Peter Kahl*, Air Force of the Federal Republic of Germany, 1 March 1988 to 7 July 1988.

First Lieutenant *Jochen C. Ruge*, Army of the Federal Republic of Germany, 1 March 1989 to 1 April 1989.

Captain *Oliver W.H. Thier*, Air Force of the Federal Republic of Germany, 1 March 1989 to 31 March 1990.

Major *Wedigo Von Wedel*, Army of the Federal Republic of Germany, 12 January 1988 to 30 June 1989.

**VII—ARMY ACHIEVEMENT MEDAL.** 1. On 10 April 1981, the Secretary of the Army approved a peacetime decoration to be awarded to United States Army personnel, on or after 1 August 1981, to be known as the Army Achievement Medal.

2. The obverse face of the medal will be struck to depict the United States Army seal.

3. The Army Achievement Medal will take precedence next after the Army Commendation Medal.

4. The medal will be awarded to deserving United States Army personnel in the rank of colonel or below. Members of the other United States Armed Forces may be awarded this medal. Eligibility criteria are in AR 672-5-1.

5. Only one Army Achievement Medal will be issued to any one individual. A bronze oak leaf cluster will be issued instead of a medal for each additional award. A silver oak leaf cluster will be issued instead of 5 bronze oak leaf clusters.

**VIII—ARMY ACHIEVEMENT MEDAL.** By direction of the Secretary of the Army, under the provisions of AR 672-5-1, paragraph 2-22, the Army Achievement Medal for meritorious service is awarded to the following:

Major *Andres Apolinar*, Army of the Dominican Republic, 9 January 1990 to 23 February 1990.

Major *Rolf P. Ganzhorn*, Army of the Federal Republic of Germany, 1 April 1986 to 13 July 1989.

Staff Sergeant *Severiano Jacquet Olmedo*, Paraguayan Army, 10 January 1986 to 31 December 1988.

**IX—NONCOMMISSIONED OFFICER PROFESSIONAL DEVELOPMENT RIBBON.** 1. On 10 April 1981, the Secretary of the Army approved a service ribbon to be awarded to United States Army enlisted personnel, on or after

1 August 1981, to be known as the Noncommissioned Officer Professional Development Ribbon.

2. The ribbon will be issued to Active and Reserve Component United States Army enlisted personnel for successful completion of designated noncommissioned professional Development courses.

3. The Noncommissioned Officer Professional Development Ribbon will take precedence after the Armed Forces Reserve Medal.

4. Commissioned and warrant officers are eligible for award of the ribbon when requisite criteria were met during enlisted status. Eligibility criteria are in AR 672-5-1.

5. Only one Noncommissioned Officer Professional Development Ribbon will be issued to any one individual. Numerals 2 through 4 will be issued to designate graduation from the respective courses.

**X—ARMY SERVICE RIBBON.** 1. On April 1981, the Secretary of the Army approved a service ribbon to be awarded to United States Army personnel, on or after 1 August 1981, to be known as the Army Service Ribbon.

2. The ribbon will be issued to Active and Reserve Component United States Army personnel for successful completion of initial entry training or basic/orientation course for officers.

3. The Army Service Ribbon will take precedence after the Noncommissioned Officer Professional Development Ribbon.

4. The ribbon will be awarded to United States Army personnel of all ranks. The ribbon may be awarded for training completion prior to 1 August 1981, provided the recipient is on active status on 1 August 1981. Eligibility criteria are in AR 672-5-1.

5. Only one award Army Service Ribbon is authorized, regardless of whether an individual completes both officer and enlisted initial entry training.

**XI—OVERSEAS SERVICE RIBBON.** 1. On 10 April 1981, the Secretary of the Army approved a service ribbon to be awarded to United States Army personnel, on or after 1 August 1981, to be known as the Overseas Service Ribbon.

2. The ribbon will be issued to Active and Reserve component United States Army personnel for completion of a normal overseas tour in a peacetime environment.

3. The Overseas Service Ribbon will take precedence after the Army Service Ribbon.

4. The ribbon will be awarded to United States Army personnel of all ranks. The ribbon may be awarded for overseas tours completed prior to 1 August 1981, provided the recipient is on active status on 1 August 1981, and the award of the ribbon does not duplicate the same service recognized by a campaign medal, expeditionary medal, occupation medal or humanitarian service medal. Eligibility criteria are in AR 672-5-1.

5. Only one Overseas Service Ribbon will be issued to any one individual. Numerals will be issued to reflect subsequent awards.

**XII—ARMY RESERVE COMPONENTS OVERSEAS TRAINING RIBBON.** 1. On 11 July 1984, the Secretary of the Army approved a service ribbon to be awarded to United States Army Reserve Component, on or after 11 July 1984, to be known as the Army Reserve Component Overseas Training Ribbon.

2. The ribbon will be issued to eligible Reserve Component personnel for completion of not less than 10 consecutive duty days on foreign soil, not including United States possessions and territories.

3. The Army Reserve Components Overseas Training Ribbon will take precedence after the Overseas Service Ribbon.

4. The ribbon will be awarded to United States Army Reserve Component personnel of all ranks. Eligibility criteria are in AR 672-5-1.

5. Only one Army Reserve Components Overseas Training Ribbon will be issued to any one individual. Numerals will be issued to reflect subsequent awards.

**XIII—JOINT MERITORIOUS UNIT AWARD.** By direction of the Secretary of Defense, under the provisions of Department of Defense Directive 1348-33-M, dated August 1985, award of the Joint Meritorious Unit Award to the following units of the Armed Forces of the United States for exceptionally meritorious service in pursuit of joint military missions of great significance is confirmed according to AR 672-5-1, paragraph 9-9:

**XIV—ARMY SUPERIOR UNIT AWARD.** 1. On 8 April 1985, the Secretary of the Army approved a peacetime United States Army Unit Award, for qualifying performance that does not antedate 8 April 1983, to be known as the Army Superior Unit Award.

2. The award will normally be bestowed to battalion and smaller sized units. Award to headquarters type units is allowed but would be rare.

3. The components of the award consist of a unit certificate, citation, streamer (for color bearing units) and a Superior Unit Emblem (ribbon) for wear by individual soldiers. The individual ribbon takes precedence after the Meritorious Unit Commendation ribbon.

4. Recommendations for the award must be submitted into military channels within 2 years of completion of the mission or service. Eligibility criteria are in AR 672-5-1.

5. Subsequent awards of the Superior Unit Award to the same unit are authorized. This will be signified on the individual ribbon by the wear of a bronze oak leaf cluster.

**XV—ARMY SUPERIOR UNIT AWARD.** By direction of the Secretary of the Army, under AR 672-5-1, paragraph 9-28.1, the Army Superior Unit Award is awarded to the following units of the Armed Forces of the United States for meritorious service in connection with difficult and challenging missions during peacetime.

**XVI—GOVERNMENT OF LUXEMBOURG GILDED CROSS OF HONOR AWARD.** The Government of Luxembourg's Gilded Cross of Honor and of Military Merit with Gold Palm that was awarded by the Grand-Duke of Luxembourg, Duke of Nassau to the 5TH ARMORED DIVISION, United States Army is confirmed according to AR 672-5-1, paragraph 9-39.

The citation reads as follows:

In recognition of the Division's participation in the defense of Luxembourg's territory during World War II. The 5th Armored Division, the first large Allied Unit to enter the Luxembourg territory on the 9th of September 1944, which then moved on to the German frontier to attack the defensive Siegfried Line.

So much of section IX, Department of the Army General Orders Number 6, as pertains to award of the Meritorious Unit Commendation (Navy), as reads: the "121st Evacuation Hospital, Burn Flight Team, Institute of Surgical Research," is amended to read: "121st Evacuation Hospital, Institute of Surgical Research."

2. So much of section IX, Department of the Army General Orders Number 6, is amended to add the following:


