I—FORT GEORGE G. MEADE, MARYLAND. Effective 1 October 1993, Fort George G. Meade (UIC: FCW0USAA), an installation under the command of the Commanding General, U.S. Army Forces Command, Fort McPherson, Georgia, is transferred to the command of the Commanding General, U.S. Army Military District of Washington, Fort Lesley J. McNair, Washington, DC (UIC: MWW0USAA).

II—FORT A. P. HILL, VIRGINIA. Effective 1 October 1993, Fort A. P. Hill (UIC: FCW0US45), an installation under the command of the Commanding General, U.S. Army Forces Command, Fort McPherson, Georgia, is transferred to the command of the Commanding General, U.S. Army Military District of Washington, Fort Lesley J. McNair, Washington, DC (UIC: MWW0US45).

III—FORT HOLABIRD, MARYLAND. Effective 1 October 1993, Fort Holabird (UIC: FCW0USAA), a sub-installation of Fort Meade under the command of the Commanding General, U.S. Army Forces Command, Fort McPherson, Georgia, is transferred to the command of the Commanding General, U.S. Army Military District of Washington, Fort Lesley J. McNair, Washington, DC (UIC: MWW0USAA).

IV-FORT RITCHIE, MARYLAND. Effective 1 October 1993, Fort Ritchie (UIC: CZW065AA), an installation under the command of the Commanding General, U.S. Army Information Systems Command, Fort Huachuca, Arizona, is transferred to the command of the Commanding General, U.S. Army Military District of Washington, Fort Lesley J. McNair, Washington, DC (UIC: MWW065AA).

V—UNITED STATES ARMY FORT BELVOIR. Effective 1 October 1993, the United States Army Fort Belvoir (UIC: MWW4VNAA) is redesignated Fort Belvoir (UIC: MWW4VNAA).

VI—FORT LESLEY J. MCNAIR, WASHINGTON, D.C. Effective 1 October 1993, Fort Lesley J. McNair (UIC: MWW3J806), an installation under the command of the Commanding General, U.S. Army Military District of Washington, Fort Lesley J. McNair, Washington, DC is redesignated a sub-installation of Fort Myer, Virginia (UIC: MWW3J806).

VII-CAMERON STATION, VIRGINIA. Effective 1 October 1993, Cameron Station, Virginia (UIC: MWW3J808), an installation under the com-
