HEADQUARTERS DEPARTMENT OF THE ARMY WASHINGTON, DC, 30 September 1994

ESTABLISHMENT OF THE UNITED STATES ARMY INFORMATION MANAGEMENT SUPPORT CENTER (IMCEN)

1. Effective 1 October 1994, the U.S. Army Information Management Support Center (UIC: SJW06HAA) is ESTABLISHED as a field operating agency under the Office of the Administrative Assistant, Office of the Secretary of the Army. The IMCEN is responsible for performance of the following mission:

Provide all information management support and services internal to the Headquarters, Department of the Army and its assigned agencies and activities that constitute the "Headquarters MACOM" so as to ensure the timely, effective, and efficient delivery of information mission area support and services to the Headquarters.

- 2. The U.S. Army Information Management Support Center will be located in the National Capital Region. Personnel assigned will work under the oversight of the Headquarters, Information Manager (HQIM), Office of the Administrative Assistant to the Secretary of the Army.
- 3. Effective 1 October 1994, the U.S. Army Decision Systems Management Agency (UIC: SFW4KBAA) is DISESTABLISHED.
- 4. Effective 1 October 1994, the U.S. Army Management Systems Support—Washington (UIC: SJW4ZSAA) is DISESTABLISHED.
- **5.** Effective 1 October 1994, the U.S. Army Plans and Operations Information Support Agency (UIC: SSW4XCAA) is DISESTABLISHED.
- **6.** Effective 1 October 1994, the Information Management function is WITHDRAWN from the U.S. Army Information Management Support Agency (UIC: SSW4M7AA) and REASSIGNED to the U.S. Army Information Management Support Center.
- 7. Effective 1 October 1994, the functions of HQDA Information Management Area Policy, Planning, and Architecture; HQDA Records Management, and the HQDA Chiefs and Executive Booklet and Army Information Book (AIB) publishing functions are WITHDRAWN from the U.S. Army Information Systems Command—Pentagon, and REASSIGNED to the U.S. Army Information Management Support Center.
- 8. Effective 1 October 1994, the Information Management function is WITHDRAWN from the U.S. Army Force Integration Support Agency (UIC: SFW4PCAA) and REASSIGNED to the U.S. Army Information Management Support Center.
