## I—FORT ORD, CALIFORNIA (06653).

- 1. Effective 30 September 1994, Fort Ord (06653) was inactivated pending disposal of excess property (Public Law 101-510).
- 2. Effective 1 October 1994, Monterey Recreation Site (06309) was transferred to the command of the Commander, Defense Language Institute, Foreign Language Center and Presidio of Monterey (06305).
- 3. Effective 1 October 1994, Fort Ord USAR Center was activated as a subinstallation of Fort Lewis, Washington, and assigned to the command of the Commanding General, Fort Lewis (53456).
- 4. Effective 1 October 1994, Fort Ord (06653) was transferred from the command of the Commanding General, U.S. Army Forces Command to the command of the Commanding General, U.S. Army Training and Doctrine Command.
