REALIGNMENT OF CIVILIAN PERSONNEL AND ASSOCIATED FUNCTIONS

1. Effective 1 November 1996, in accordance with the Department of Army, United States Army Information Systems Command Permanent Order 198-4, dated 16 July 1996, the following missions, manpower spaces, and equipment are established within PERSCOM under the Parent UIC W3VSAA, Command Code MP:

Automation Enlisted Records and Evaluation Center, Fort Benjamin Harrison, UIC derivative W3VS10 (formerly United States Army Information Systems Command-Enlisted Records Center (USAISC-EREC) (W4UL06).

Automation Central Clearance Facility, Fort Meade, UIC derivative W3VSl6 (formerly United States Army Information Systems Command-Central Clearance Facility (USAISC-CCF) (W4UL05).

Automation Reserve Personnel Center. St. Louis, UIC derivative W3VS26 (formerly United States Army Information Systems Command-Army Reserve Personnel Center (USAISC-ARPERCEN) (W4URAA).

Automation Recruiting Command, Fort Knox, UK derivative W3VS27 (formerly United States Army Information Systems Command-United States Army Recruiting Command (USAISC-USAREC) (W37BAA with derivative UICs W37B01, W37B02, W37B04, and W37B05)).

Automation Research Institute, Alexandria, UIC derivative W3VS28 (formerly United States Army Information Systems Command-Army Research Institute (USAISC-ARI) (W4UMAA).

Automation Military Entrance Processing Command, Great Lakes, UIC derivative, W3VS29 (formerly United States Army Information Systems Command-United States Military Entrance Processing Command (USAISC-MEPCOM) (W4GRAA).

Personnel Information Management Directorate on Parent UIC W3VSAA (formerly United States Army Personnel Information Systems Command (PERSINSCOM) (W4ULAA).

Information Management Division, on Parent UIC W3VSAA (formerly United States Army Information Systems Command-Hoffman (DOIM) (WAUSAA).

Automation Civilian Personnel Management Directorate, on Parent UIC W3VSAA (formerly United States Army Information Systems Command-Civilian Personnel Management Directorate (ISC-CPMD) (WIC3AA).

2. The UICs W4USAA, W4URAA, W37BAA, W4GRAA, WIC3AA, W4UMAA, and W4ULAA and derivatives W4UL05, W4UL06, W37B01, W37B02, W37B04, and W37B05 previously assigned to these subelements, were disestablished by Permanent Order 198-4, 16 July 1996, effective 1

November 1996 by the Department of Army, Headquarters, United States Army Information Systems Command, Fort Huachuca, Arizona.

- 3. At the same time, in accordance with the Department of Army, Office of the Assistant Secretary, Manpower and Reserve Affairs memorandum, dated August 1, 1996, the Automation Civilian Personnel Management Directorate is transferred from PERSCOM to the Civilian Personnel Field Agency of OASA(M&RA), new UIC W40WAA, Command Code SB.
- 4. At the same time, in accordance with Department of the Army, United States Total Army Personnel Command, Deputy Chief of Staff for Resource Management memorandum, dated 19 September 1996, the Automation Military Entrance Processing Command is transferred from PERSCOM to USMEPCOM, UIC W37NAA, Command Code PC.
- 5. Administrative and logistical support for each organization will continue in accordance with their present support agreements.
