**REDESIGNATION OF JUNIOR RESERVE OFFICERS'  
TRAINING CORPS (JROTC) UNITS**

Headquarters, Department of the Army General Orders No. 25 (ROTC Units), dated 15 June 1966, is amended as follows:

Paseo High School, JROTC UNIT, location: Kansas City, MO, effective 1 July 1966, is redesignated: East High School, Kansas City, MO, effective: 25 August 2008.

Northern High School, JROTC UNIT, location: Detroit, MI, effective 1 July 1966, is redesignated: Detroit International Academy, Detroit, MI, effective: 1 September 2008.

Treadwell High School, JROTC UNIT, location: Memphis, TN, effective 1 July 1966, is redesignated: Douglas High School, Memphis, TN, effective: 30 September 2008.

Headquarters, Department of the Army General Orders No. 41 (JUNIOR ROTC UNITS), dated 24 July 1970, is amended as follows:

Colonel White High School, JROTC UNIT, location: Dayton, OH, effective 1 April 1980, is redesignated: Thurgood Marshall High School, Dayton, OH, effective: 1 September 2008.

Southside Comprehensive High School, JROTC UNIT, location: Atlanta, GA, effective 1 August 1985, is redesignated: Maynard Holbrook Jackson High School, Atlanta, GA, effective: 30 September 2008.
